- 2. This Order applies to the land listed in the Schedule and marked in red on a plan labelled "Ormidhia to Xylophagou Road" which is available for inspection at the Area Office Dhekelia during normal working hours ("the Requisitioned Land").
- 3. The Requisitioned Land is required for the improvement of the road between Ormidhia and Xylophagou and deemed a public benefit under section 3 of the Land Requisition Ordinance 2016.

EXPLANATORY NOTE

(This note is not part of the Order)

- 1. This explanatory note relates to the Land Requisition (Ormidhia to Xylophagou Road) Order 2023 (the "Order"). It has been prepared by the Office of the Attorney General and Legal Adviser in order to assist the reader of the Order.
- **2.** The Order is made under the Land Requisition Ordinance 2016 (the "Ordinance"), which sets out the statutory framework for the requisition of land for a purpose of public benefit. Section 3 of the Ordinance defines a purpose of public benefit.
- **3.** The Order relates to requisitioning land for the period of six months for the purpose of improvement of a road, connecting Ormidhia and Xylophagou, both of which are in the District of Larnaca in the Republic of Cyprus.
