FIXED PENALTY ORDINANCE 2010

An Ordinance to provide for the avoidance of prosecution for certain offences by payment of fixed penalties

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:—

PART I(a)

General

Short title

1. This Ordinance may be cited as the Fixed Penalty Ordinance 2010.

Interpretation

2. In this Ordinance—

"fixed penalty" means a penalty imposed under section 3(1) or (2) *or section 12(1) or (2) (b)* and includes any increase in such a penalty under section 4(b) *or section 13;(c)*

~~"investigating officer" means an investigating officer authorized to investigate into the commission of an offence under section 4(2) of the Criminal Procedure Ordinance (d); (e)~~

"investigating officer" means a person authorised to investigate into the commission of an offence in accordance with section 11(2) of the Criminal Procedure Ordinance 2016 (investigating officers)(f).

"notice" means a notice to which section 3 *or section 12(g)* applies.

"officer in charge of a police station" has the same meaning as the Criminal Procedure Ordinance 2016(h). (i)

Serving of notice on offenders

3.—(1) A police officer who suspects that a person is committing or has committed an offence, which is listed in the columns headed "Legislation" and "Provision" in Schedule 1 or Schedule 2, may issue and serve within 45 days of the commission of the offence on such person a notice in writing giving that person the opportunity of avoiding prosecution in relation to such offence by paying a fixed penalty.

(2) In relation to offences listed in the columns headed "Legislation" and "Provision" in Schedule 2, a notice may also be issued and served as provided for in subsection (1) by—

- (a) an Area Officer; or
- (b) an investigating officer if the offence is one that the investigating officer is authorised to investigate; or
- (c) *in the case of an offence under the Dogs Ordinance 2006(a) in relation to land occupied, or to which access is controlled or restricted, by the Crown and premises on such land, any person appointed by the Chief Officer. (b)*

(3) The amount of a fixed penalty which is imposed for any offence under subsection (1) or (2) is the amount shown in the column headed “Fixed Penalty” in Schedule 1 or Schedule 2 in relation to that offence.

(4) The powers conferred by subsection (2) are modified general delegated functions under the Delegation of Functions to the Republic Ordinance 2007(c) in respect of the offences set out in serial numbers 1, 2, 3, 4, 5, 6, 23, 24, 25, 26, 28, 29, 32, 33, ~~35, 36, 37, 38,~~(d) 55, 56, 57, 58, 59, 60, 61, 62, 63, 64, 73, 74, 75, 76, 95, 108, 109, 110, 111, 112, 113, 114, 115, 116, 117, 118, 127, (e)128, 129 and 130 of Schedule 2 130, 152, and 153 of Schedule 2. (f)

(5) The modification referred to in subsection (4) is that section 18(c) (prohibition on compounding any offence) of the Delegation of Functions to the Republic Ordinance 2007 does not apply.

Criminal proceedings and increase of fixed penalty after serving of notice

4. If a notice is served in relation to an offence—

- (a) proceedings must not be instituted for that offence within ~~30~~ 45(g) days of the service of the notice;
- (b) the amount payable by way of fixed penalty is increased by 50% if it is not paid within ~~15~~ 30(h) days of the service of the notice;
- (c) the person served with the notice must not be prosecuted for that offence if the fixed penalty, including any increase in that penalty under paragraph (b), is paid within ~~30~~ 45(i) days of the service of the notice.

Content of Notice

5. A notice must provide sufficient particulars of the circumstances alleged to constitute the offence and must state—

- (a) the period during which, by virtue of section 4, proceedings must not be brought for the offence;
- (b) the amount of the fixed penalty including any increase which would arise as a result of non-payment within 15 days;
- (c) the person to whom and the address at which the fixed penalty may be paid;
- (d) that the fixed penalty may be paid—
 - (i) in cash;
 - (ii) by cheque; or
 - (iii) by any other method determined by the Chief Officer by notice published in the Gazette.

Evidence of payment

6.—(1) The person to whom a fixed penalty is paid under section 5 must issue a receipt for the payment and in any court proceedings such receipt is admissible as evidence of that payment.

(2) Payment of a fixed penalty is not a conviction for the offence to which the fixed penalty relates.

Affixing a notice to a vehicle

7.—(1) A police officer, who suspects that an offence which is included in Schedule 1 has been committed in relation to a motor vehicle, may affix a notice to that vehicle.

(2) Affixing a notice to a motor vehicle constitutes service of the notice on the owner of the vehicle.

(3) If a notice has been served in accordance with this section, the fixed penalty is payable by the owner of the vehicle.

(4) In this section, “owner of the vehicle” means the person in whose name a motor vehicle is registered or, in relation to a vehicle which is the subject of a hiring or a hire purchase agreement, the person in possession of the vehicle under the agreement.

Removal of notice prohibited

8. Any person other than the driver or person in charge of the vehicle, its registered owner or a person acting with the authority of the registered owner who removes or otherwise tampers with a notice affixed to the vehicle in accordance with section 7 commits an offence and is liable to a fine of €85.

Regulation and order making power

9.—(1) The Administrator may make regulations in respect of any matter relevant to the implementation of this Ordinance and more particularly with regard to—

- (a) the form of a notice and the form of the receipt issued under section 6; and
- (b) the duties of police officers, Area Officers or investigating officers in relation to the implementation of this Ordinance.

(2) The Administrator may by order amend the particulars of either of the Schedules including the amounts of the fixed penalties for any offence set out in the Schedules, which must not exceed the maximum amount of fine provided in the legislation creating the offence.

PART 2 (e)

Offences under the Game and Wild Birds Ordinance 2008

Application and interpretation

11.—(1) *This Part applies to offences committed under the 2008 Ordinance.*

(2) *In this Part, and Schedule 3,—*

“2008 Ordinance” means the Game and Wild Birds Ordinance 2008(f);

“game warden” has the meaning assigned to it by section 2 of the 2008 Ordinance;

“RoC Schedule 1” means Schedule I of the corresponding Republican Law;

“RoC Schedule 9” means Schedule IX of the corresponding Republican Law;

“section 28A(2) fine” means the maximum fine referred to in section 28A(2) of the 2008 Ordinance(g); and

“section 55 fine” means the maximum fine referred to in section 55 of the 2008 Ordinance(h).

Serving of notice on offenders: offences under the 2008 Ordinance

12.—(1) *The following persons may issue and serve a notice in writing on a person they suspect is committing or has committed any offence under the 2008 Ordinance within 45 days of the commission of the offence giving that person the opportunity of avoiding prosecution in relation to such offence by paying a fixed penalty—*

(a) a police officer; or

(b) a game warden authorised in writing by the Chief Officer to issue a fixed penalty in respect of that offence.

(2) *In relation to the offences referred to in Part 1 of Schedule 3, a notice may also be issued and served as provided for in subsection (1) by—*

(a) an Area Officer; or

(b) an investigating officer if the offence is one that the investigating officer is authorised to investigate.

(3) *The power conferred by subsection (2) is a modified general delegated function under the Delegation of Functions to the Republic Ordinance 2007 in respect of the offences set out in serial number 14 of Part 1 of Schedule 3.*

(4) *The modification referred to in subsection (3) is that section 18(c) (prohibition on compounding any offence) of the Delegation of Functions to the Republic Ordinance 2007(i) does not apply.*

Criminal proceedings and increase of fixed penalty after serving of notice: offences under the 2008 Ordinance

13. If a notice is served in relation to an offence under the 2008 Ordinance—

- (a) proceedings must not be instituted for that offence within 45 days of the service of the notice;*
- (b) the amount payable by way of fixed penalty is increased by 50% if it is not paid within 30 days of the service of the notice;*
- (c) the person served with the notice must not be prosecuted for that offence if the fixed penalty, including any increase in the penalty under paragraph (b), is paid within 45 days of the service of the notice.*

Content of notice: offences under the 2008 Ordinance

14. A notice must provide sufficient particulars of the circumstances alleged to constitute an offence under the 2008 Ordinance and must state—

- (a) the period during which, by virtue of section 13, proceedings must not be brought for the offence;*
- (b) the amount of the fixed penalty including any increase which would arise as a result of non-payment within 30 days;*
- (c) the person to whom and the address at which the fixed penalty may be paid;*
- (d) that the fixed penalty may be paid—*
 - (i) in cash;*
 - (ii) by cheque; or*
 - (iii) by any other method determined by the Chief Officer by notice published in the Gazette.*

Evidence of payment: offences under the 2008 Ordinance

15.—(1) The person to whom a fixed penalty is paid under section 14 must issue a receipt for the payment and in any court proceedings such receipt is admissible as evidence of that payment.

(2) Payment of a fixed penalty is not a conviction for the offence to which the fixed penalty relates, but a court may take it into account when considering sentencing in relation to the commission of similar offences.

Fixed penalties: offences under the 2008 Ordinance

16.—(1) Subject to subsection (6) the amount of a fixed penalty which is imposed for any offence under the 2008 Ordinance not referred to in Schedule 3 is 10% of the section 55 fine.

(2) The amount of a fixed penalty which is imposed for an offence under section 55B of the 2008 Ordinance (attempts to commit offences) is the same as if the person had actually committed the offence they attempted to commit.

(3) Subject to subsections (5) and (6) the amount of a fixed penalty which is imposed for any offence listed in Schedule 3 is the amount shown in the column headed “Fixed Penalty” in relation to that offence.

(4) Subsection (5) applies where—

- (a) a person (P) has been issued with a notice in respect of an offence referred to in Part 2 Table 1 of Schedule 3, and*
- (b) as a result of the investigation of that offence P is suspected of having committed a related offence under the 2008 Ordinance, ~~set out in serial numbers 23 and 24~~*

other than one set out in serial numbers 1-22 and 25 to 28 (a) of Part 1 of Schedule 3 (O).

(5) Subject to subsection (6), the amount of the fixed penalty imposed for O is 5% of the section 55 fine.

(6) The maximum amount of a fixed penalty that may be imposed in respect of an offence under the 2008 Ordinance is the maximum fine that could be imposed by a court for that offence.

Procedure for issuing notices: offences in Part 2 Table 1 of Schedule 3

17.—(1) This section applies to notices issued in respect of the offences referred to in Part 2 Table 1 of Schedule 3.

(2) Before issuing a notice the police officer or game warden must seize the evidence relating to the offence, take it to a police station and prepare a statement setting out the details of the offence.

(3) Any evidence seized by a game warden in accordance with subsection (2) must be handed over to the officer in charge of the police station who must take possession of it.

(4) The evidence referred to in subsection (2) must be brought before a Judge.

(5) Section 46 of the Criminal Procedure Ordinance 2016 applies to an item brought before a Judge under subsection (4) as it applies to an item brought before a Judge in accordance with section 36 of that Ordinance.
