BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:-

1. This Ordinance may be cited as the Documents (Special Duty) (Amendment) Ordinance, 1969 and shall be read as one with the Documents (Special Duty) Ordinance, 1962 (hereinafter referred to as "the principal Ordinance").
