ORDINANCE 4 OF 1978.

AN ORDINANCE

TO AMEND THE CRIMINAL PROCEDURE ORDINANCE.

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:—

1. This Ordinance may be cited as the Criminal Procedure (Amendment) Ordinance, 1978 and shall be read as one with the Criminal Procedure Ordinance, as amended from time to time (hereinafter referred to as "the principal Ordinance").

Short title.

Cap. 155 (Laws of Cyprus), Ordinances, 4/60, 19/63, 1/66, 2/72, 2/73 and 10/75.

2. Section 88 of the principal Ordinance is hereby amended by deleting the words "twenty-five pounds" appearing in the fifth line thereof and substituting therefor the words "one hundred and twenty-five pounds".

TO AMEND THE EVIDENCE ORDINANCE.

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:—

Short title.

1. This Ordinance may be cited as the Evidence (Amendment) Ordinance, 1978 and shall be read as one with the Evidence Ordinance (hereinafter referred to as “the principal Ordinance”).

Schedule to the principal Ordinance amended.

2. The Schedule to the principal Ordinance is hereby amended by inserting immediately under the figure and word “146-Attempt” the figure and word “147-Incest”.

ORDINANCE 6 OF 1978.

AN ORDINANCE

TO AMEND THE IMMOVABLE PROPERTY
(TEMPORARY PROVISIONS) ORDINANCE, 1977.

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows :—

1. This Ordinance may be cited as the Immovable Property (Temporary Provisions) (Amendment) Ordinance, 1978 and shall be read as one with the Immovable Property (Temporary Provisions) Ordinance, 1977 (hereinafter referred to as "the principal Ordinance").

Short title.

Ordinance 10/77.

2. Section 6 of the principal Ordinance is hereby amended by deleting the first proviso thereto and substituting therefor the following new proviso :—

Section 6 of the principal Ordinance amended.

"Provided that the tax for the year 1977 shall be payable on the 1st October, 1978 and for the year 1978 on the 1st January, 1979 :".

3. Section 8 of the principal Ordinance is hereby amended by substituting a colon for the full stop at the end thereof and inserting immediately thereafter the following proviso :—

Section 8 of the principal Ordinance amended.

"Provided that if the tax for the year 1977 is not paid by the 31st December, 1978 and the tax for the year 1978 is not paid by the 31st March, 1979 then the said surcharge shall be imposed."

Schedule to

repealed and
replaced.

4. The principal Ordinance is hereby amended by repealing the Schedule thereto and substituting therefor the following new Schedule.

“ S C H E D U L E

(Section 3).

1. The rates of tax shall be as set out below :

| (i) On any type of building other than a dwelling house— | |
| of an assessed value up to £500 | ½% |
| of an assessed value in excess
of £500 but not exceeding £1,000 | ¾% |
| of an assessed value in excess of £1,000
but not exceeding £2,000 | 1% |
| of an assessed value in excess of 2,000 | 1¼% |
| (ii) On any other immovable property— | |
| of an assessed value up to £50 | 1½% |
| of an assessed value in excess
of £50 but not exceeding £100 | 1¾% |
| of an assessed value in excess of £100 | 2% |

Provided that where the total amount of tax assessed does not exceed five hundred mils, such tax shall be waived.

2. The progressive rates of tax listed above, shall be levied and collected in accordance with the registered or assessed value of any property and shall not be aggregated with the value of any property belonging to the same person.”
