ORDINANCE 8 OF 1982.

**AN ORDINANCE**

TO AMEND THE CRIMINAL CODE.

**BE** it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:—

1. This Ordinance may be cited as the Criminal Code (Amendment) Ordinance, 1982 and shall be read as one with the Criminal Code, as amended from time to time (hereinafter referred to as “the principal Ordinance”).

Short title.  
Cap. 154 (Laws of Cyprus), Ordinances 11/63, 17/63, 10/66, 8/72, 1/73, 4/74 and 7/79.

2. The principal Ordinance is hereby amended by repealing Section 218 thereof and substituting therefor the following new Section:—

Section 218 of the principal Ordinance repealed and replaced.

“Criminal liability for complicity in another’s suicide.”

218. A person who aids, abets, counsels or procures the suicide of another, or an attempt by another to commit suicide, shall be guilty of a felony and shall be liable on conviction to imprisonment for ten years.”.

3. Section 219 of the principal Ordinance is hereby repealed.

Section 219 of the principal Ordinance repealed.

ORDINANCE 9 OF 1982.

AN ORDINANCE

TO AMEND THE FACTORIES ORDINANCE.

**BE** it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:—

Short title.  
Cap. 134 (Laws

1. This Ordinance may be cited as the Factories (Amendment) Ordinance, 1982 and shall be read as one with the Factories Ordinance, as amended from time to time (hereinafter referred to as “the principal Ordinance”).

Section 3 of

2. Section 3 of the principal Ordinance is hereby amended by inserting in subsection (1) thereof in its appropriate alphabetical position the following new definitions:—

“agricultural operations” includes flower growing, fruit growing, forestry, the breeding and keeping of animals (including their transportation to the place of slaughtering or their export), bee keeping, sericulture and the preparation of land for agricultural use; and the word “agricultural” shall be construed accordingly;

“animal” includes any animal or bird kept for the production of food, wool, skins or fur, or for the purpose of any agricultural work;

“forestry” includes—

- (a) preparation of the land and its planting up for the purpose of establishing a forest; and
- (b) the felling of trees, their uprooting as well as their primary conversion to timber in the forest in which they grew.

3. The principal Ordinance is hereby amended by inserting immediately after Section 76, the following new Section to be numbered 76A :—

New Section  
76A added to

"Agricultural  
operations.

76A. (1) Subject to the provisions of this Section, the provisions of this Ordinance which are referred to in this subsection shall apply to agricultural operations undertaken by way of a trade or for the purpose of any industrial or commercial undertaking, that is to say :

- (a) Part I,
- (b) Part II,
- (c) Part III,
- (d) the provisions of Part IV relating to sanitary conveniences and the powers to require medical supervision ;
- (e) the provisions of Part V relating to the secure fencing of prime movers, parts of any transmission machinery and other machinery and the provisions relating to the powers of the Court to issue orders in respect of dangerous situations and practices ;
- (f) Part VI ;
- (g) the provisions of Part VII relating to special rules in respect of safety, health and welfare ;
- (h) the provisions of Part IX relating to the duties of persons employed and the prohibition of deductions from wages ;
- (i) the provisions of Part X relating to the powers and duties of Inspectors, the powers of the Chief Officer and the provisions as to regulations, rules and orders made under the Ordinance ;
- (j) Part XI.

(2) The provisions of this Ordinance, in so far as they are applicable to agricultural operations, shall apply as if the sites where such operations are carried out were a factory and any person engaged in those operations to which this Ordinance applies were the occupier of a factory with such modifications and amendments as may be provided by the Ordinance."
