ORDINANCE 5 OF 1990.

AN ORDINANCE

TO AMEND THE TERMINATION OF EMPLOYMENT (CONSOLIDATION) ORDINANCE, 1980.

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows :---

1. This Ordinance may be cited as the Termination of Employment (Consolidation) (Amendment) Ordinance, 1990 and shall be read as one with the Termination of Employment (Consolidation) Ordinance, 1980 as amended from time to time (hereinafter referred to as "the principal Ordinance.").

2. Section 2 of the principal Ordinance is hereby amended by inserting in the appropriate alphabetical order the following new definition:—

""pensionable age" means the pensionable age defined in the Social Insurance (Facilitation of Republican Social Insurance Scheme) Ordinance, 1980.".

3. Section 4 of the principal Ordinance is hereby amended by deleting the words "attained the age of sixty-five years" appearing in the fourth line thereof and substituting therefor the words, "completed pensionable age.".

4. Section 26 of the principal Ordinance is hereby repealed and replaced by the following new Section:—

"Abatement of redundancy payment. 26.—(1) An employee shall not be entitled to a redundancy payment if before the date of termination of employment he has completed pensionable age.

Section 26 of the principal Ordinance repealed and replaced. (2) Where the employment of an employed person is terminated within the period of the last twelve months before the completion of pensionable age, any redundancy payment due under the provisions of this Ordinance shall be reduced by one-twelfth for each completed month of the age of the employed person, which is contained in the said period of time.

(3) The Administrator may, by Order in the Gazette, after consultation with the appropriate authorities of the Republic, vary the age and period of time prescribed in subsections (1) and (2) of this Section."

Date of effect of this Ordinance.

5. This Ordinance shall be treated as having come into effect on 2 April, 1990.

ORDINANCE 6 OF 1990.

AN ORDINANCE

TO AMEND THE RURAL CONSTABLES ORDINANCE.

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows :—

1. This Ordinance may be cited as the Rural Constables (Amendment) Ordinance, 1990 and shall be read as one with the Rural Constables Ordinance as amended by Ordinance 25 of 1963 (hereinafter referred to as "the principal Ordinance".).

- 2. Section 9 of the principal Ordinance is hereby amended :---
 - (a) by deleting subsection (2) thereof and substituting therefor the following new subsection:—

"(2) The Chairman of a Village Commission may resort to legal action in order to collect any sum which may still be owing after the 6th day of September in any year and may collect such sum together with the additional amount, also the costs of action, as a debt owing to the Rural Constables Fund.";

- (b) by deleting the words "twenty-five per centum" appearing in the third line of subsection (3) thereof and substituting therefor the words "fifteen per centum";
- (c) by deleting subsection (4) thereof and substituting therefor the following new subsection :

"(4) The additional amount collected under subsection (3) shall be paid into the Rural Constables Fund.".
