AN ORDINANCE

TO AMEND THE CUSTOMS AND EXCISE DUTIES
ORDINANCE, 1989.

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows :—

1. This Ordinance may be cited as the Customs and Excise Duties (Amendment) Ordinance, 1990 and shall be read as one with the Customs and Excise Duties Ordinance, 1989 as amended by the Customs and Excise Duties (Amendment) (No. 1) Ordinance, 1989 (hereinafter referred to as “the principal Ordinance”).

2. The principal Ordinance is hereby amended by repealing the Second, Fourth and Fifth Schedules thereto as set out in Supplement No. 2B of the Sovereign Base Areas Gazette No. 854 of the 10th July, 1989 and by substituting therefor the Second, Fourth and Fifth Schedules to the principal Ordinance which are set out in Supplement No. 2B of the Sovereign Base Areas Gazette No. 912 of the 8th October, 1990, printed separately, the provisions of which form part of this Ordinance.

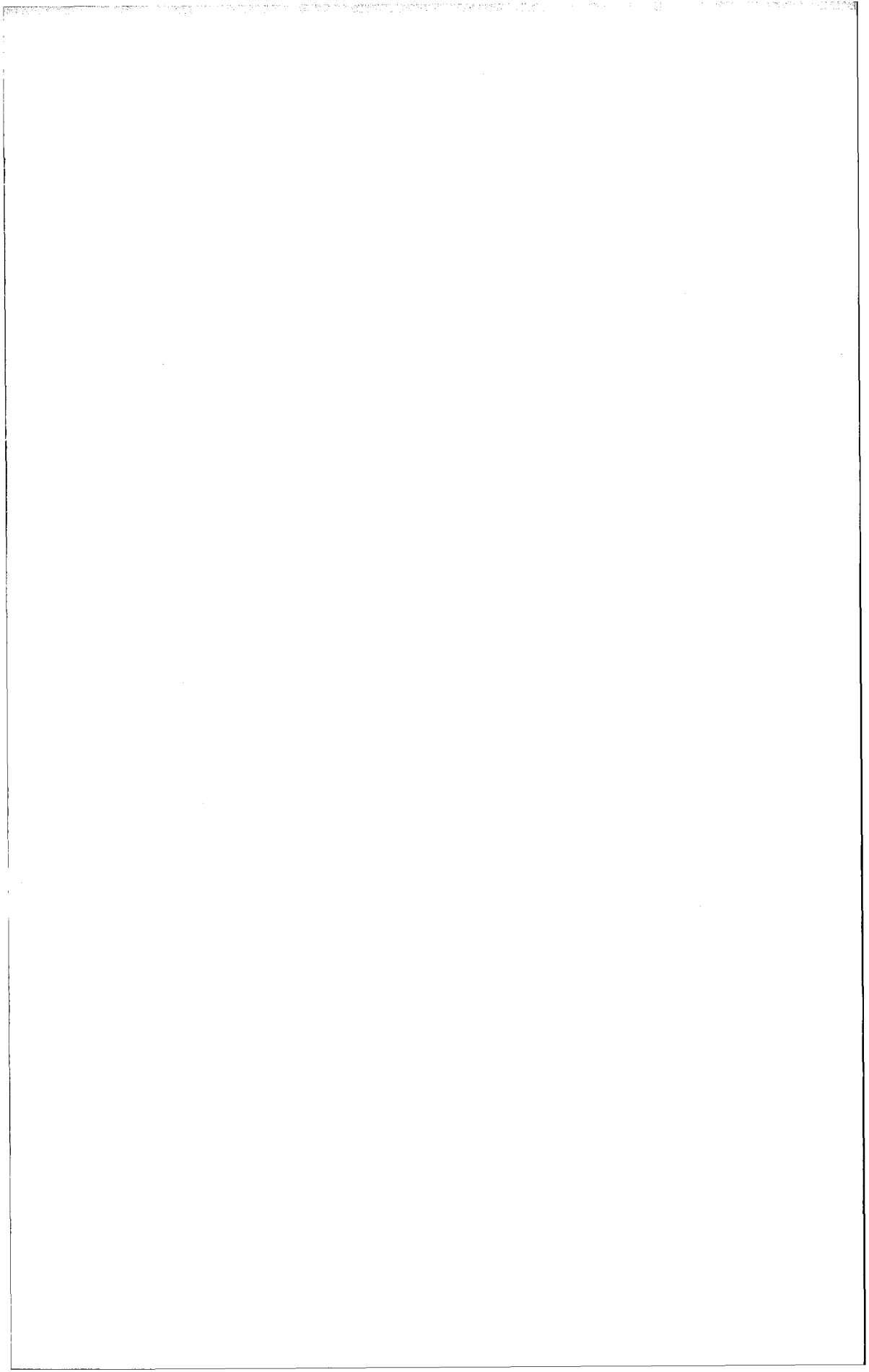
The Second, Fourth and Fifth Schedules to the principal Ordinance repealed and replaced.
