ORDINANCE 10 OF 1992

AN ORDINANCE
TO AMEND THE LAWS (ADAPTATION AND INTERPRETATION)
(CONSOLIDATION AND EXTENSION) ORDINANCE.

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows :-

1. This Ordinance may be cited as the Laws (Adaptation and Interpretation) (Consolidation and Extension) (Amendment) Ordinance, 1992 and shall be read as one with the Laws (Adaptation and Interpretation) (Consolidation and Extension) Ordinance, 1968 as amended by Ordinance No. 10 of 1988 (hereinafter referred to as "the principal Ordinance").

Short title.

Ordinances 5 of 1968 and 10 of 1988.

2. Section 2 of the principal Ordinance is hereby amended -

Section 2 of the principal Ordinance amended.

(a) by deleting the definition of "Legal Adviser" appearing therein and substituting therefor in the appropriate alphabetical order the following:-

"Attorney General and Legal Adviser" means the Attorney General and Legal Adviser to the Administrator of the Sovereign Base Areas;

(b) by deleting the definition of "Chief Police Officer" appearing therein and substituting therefor in the appropriate alphabetical order the following :-

"Chief Constable of the Sovereign Base Areas" means the Officer in charge of the Sovereign Base Areas Police Force."

3. Section 4 of the principal Ordinance is hereby amended :-

Section 4 of the principal Ordinance amended.

(a) by deleting the words "Legal Adviser" appearing in paragraph (e) of subsection (1) thereof and substituting therefor the following :-

"Attorney General and Legal Adviser" and

(b) by deleting the words "Chief Police Officer" appearing in paragraph (f) of subsection (1) thereof and substituting therefor the following :-

"Chief Constable of the Sovereign Base Areas".

AN ORDINANCE

TO PROVIDE FOR THE RENAMING OF POSTS OF CERTAIN OFFICERS IN THE SOVEREIGN BASE AREAS ADMINISTRATION.

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows :-

1. This Ordinance may be cited as the Officers of the Administration (Renaming of Posts) Ordinance, 1992.

Short title.

2. In this Ordinance -

Interpretation.

"Attorney General and Legal Adviser" means the Attorney General and Legal Adviser to the Administrator of the Sovereign Base Areas.

"Chief Constable of the Sovereign Base Areas" means the officer in charge of the Sovereign Base Areas Police Force.

3. In any enactment to which this Ordinance applies, the following provisions shall, unless the context otherwise requires, have effect, that is to say :-

Renaming of posts.

(a) Any reference to the Administrative Secretary shall be construed as a reference to the Director of Administration ;

(b) any reference to the Chief Police Officer shall be construed as a reference to the Chief Constable of the Sovereign Base Areas;

(c) any reference to the Establishment Officer shall be construed as a reference to the Finance and Personnel Officer;

(d) any reference to the Legal Adviser shall be construed as a reference to the Attorney General and Legal Adviser.

4. The enactments to which this Ordinance applies are, any Ordinances of the Areas enacted since the 16th day of August, 1960 and any public instruments made under or by virtue of any such Ordinance.
