ORDINANCE 2 OF 1993

AN ORDINANCE
TO AMEND THE POLICE ORDINANCE, 1967.

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows :-

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:-

1. This Ordinance may be cited as the Police (Amendment) Ordinance, 1993 and shall be read as one with the Police Ordinance, 1967 as amended from time to time (hereinafter referred to as "the principal Ordinance").

2. The principal Ordinance is hereby amended by deleting throughout the Ordinance the title "Deputy Chief Police Officer" wherever such title appears and substituting therefor the title "Deputy Chief Constable".

3. Section 2 of the principal Ordinance is hereby repealed and replaced by the following new Section:-

"Interpretation. 2. In this Ordinance, unless the context otherwise requires -

"Chief Constable" means the Officer in charge of the Sovereign Base Areas Police;

"Chief Superintendent" means a Divisional Commander;

"Chief Inspector" means an Inspector of Police who may also act as deputy to a Superintendent of Police;

"Court" means the Senior Judge's Court or the Judge's Court in exercise of its competent jurisdiction;

“Deputy Chief Constable” means the Deputy to the Chief Constable;

“Division” means one of the divisions of the Sovereign Base Areas Police Force;

“Divisional Commander” means the Officer in charge of a Division;

“finger-print” includes thumb-print and/or palm print;

“Force” means the Sovereign Base Areas Police Force and includes special constables;

“Gazetted Officer” means a police officer of or above the rank of Superintendent;

“Inspector” means an Inspector of Police;

“licence” includes a permit, certificate or any other document whatsoever relating to any article or thing;

“means of conveyance” means any aircraft, animal, carriage, vessel, bicycle, motor vehicle of any description or any other vehicle used for the purpose of conveyance of persons or goods;

“member of the Force” means any police officer and includes special constables;

“officer in charge of Police” means the police officer appointed by the Chief Constable to be in charge of the Police in any place;

“police officer” means any member of the Force other than a special constable;

“public” in relation to any place means any number of persons or appertaining to any number of persons, whether or not consisting solely or mainly of members of the armed forces or other servants of the Crown and whether or not such persons are acting in the course of their duty;

“station” means a police station;

“Superintendent” means the deputy to the Chief Superintendent;

“trade union” has the same meaning as in the Trade Unions Ordinance or in any Ordinance amending or substituted for the same.

Section 3 of the principal Ordinance amended.

4. Section 3 of the principal Ordinance is hereby amended by numbering the existing Section as subsection (1) and by inserting the following new subsection (2):-

“(2) The Force shall consist of two divisions to be known as the Western Division, having responsibility for the Akrotiri Sovereign Base Area, and the Eastern Division, having responsibility for the Dhekelia Sovereign Base Area.”.

5. Section 4 of the principal Ordinance is hereby repealed and replaced by the following new Section:-

Section 4 of the principal Ordinance repealed and replaced

“Constitution of Force.

4. The Force shall be enrolled and shall consist of such members of the following ranks as the Administrator may direct, that is to say -

- Chief Constable,
- Deputy Chief Constable,
- Chief Superintendent,
- Superintendent,
- Chief Inspector,
- Inspector,
- Sergeant,
- Constable:

Provided that the Administrator may from time to time by notice in the Gazette, amend or vary such ranks.

6. Section 7 of the principal Ordinance is hereby amended by deleting the words “Any Deputy Chief Police Officer” appearing in the first line thereof and substituting therefor the words “The Deputy Chief Constable”.
