AN ORDINANCE
TO AMEND THE CUSTOMS AND EXCISE DUTIES
ORDINANCE, 1989.

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:-

1. This Ordinance may be cited as the Customs and Excise Duties (Amendment) Ordinance, 1994 and shall be read as one with the Customs and Excise Duties Ordinance, 1989 as amended from time to time (hereinafter referred to as "the principal Ordinance").

The principal Ordinance is hereby amended by repealing the Second, Fourth and Fifth Schedules thereto as these are set out in Supplement No.2B of the Sovereign Base Areas Gazette No.994 of the 9th June, 1993 and by substituting therefor the Second, Fourth and Fifth Schedules to the principal Ordinance which are set out in Supplement No.2B of the Sovereign Base Areas Gazette No. 1024 of the 23rd June, 1994, printed separately, the provisions of which form part of this Ordinance.

**AN ORDINANCE
TO AMEND THE VALUE ADDED TAX ORDINANCE**

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:-

Short title.

1. This Ordinance may be cited as the Value Added Tax (Amendment) Ordinance, 1994 and shall be read as one with the Value Added Tax Ordinance, 1992 as amended from time to time (hereinafter referred to as "the principal Ordinance").

2. Schedule II to the principal Ordinance is hereby amended by adding at the end thereof, the following new paragraphs:-

Schedule II to the

- “(xvi) Intermediary services for the importation into or the exportation from, the Areas or the Republic, of goods which are supplied on commission deriving from abroad;
- (xvii) the supply of hearing aids;
- (xviii) the supply of wheel-chairs for disabled persons, walking-sticks of all types, special shoes with soles which can be regulated to correct foot abnormalities;
- (xix) the supply of vaccines for medicine and veterinary medicine;
- (xx) the supply of respiratory apparatus for the treatment of asthma (air-chambers for dosimetrical breathers of nebular inhaled medicinal fluids and spirometers for determining the patient’s breathing capability).”

AN ORDINANCE

TO AMEND THE FISHERIES (CONSOLIDATION) ORDINANCE

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:-

1. This Ordinance may be cited as the Fisheries (Consolidation) (Amendment) Ordinance, 1994 and shall be read as one with the Fisheries (Consolidation) Ordinance, 1982 as amended by the Fisheries (Consolidation) (Amendment) (No.1) Ordinance, 1991 (hereinafter referred to as "the principal Ordinance").

Short title.

Ordinances 2/82 and 3/91.

2. Section 6 of the principal Ordinance is hereby amended by inserting immediately after paragraph (i) of subsection (2) thereof the following new paragraph:-

Section 6 of the principal Ordinance amended.

"(j) prohibit the use of any sea-going craft for fishing for non-profit purposes or regulate the granting of a special permit for the conducting of such fishing."
