ORDINANCE 13 OF 1999

AN ORDINANCE
TO AMEND THE CRUELTY TO ANIMALS ORDINANCE

7th July 1999.

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:-

1. This Ordinance may be cited as the Cruelty to Animals (Amendment) Ordinance 1999 and shall be read as one with the Cruelty to Animals Ordinance (hereinafter referred to as “the principal Ordinance”).

Short title.

Cap 47 (Laws of Cyprus).

2. Section 3 of the principal Ordinance is hereby amended -

Section 3 of the principal Ordinance amended.

(i) by inserting the word “or” at the end of paragraph (d) of subsection (1) thereof and by adding immediately thereafter the following new paragraph:-

“(e) cause, procure or assist in the fighting or baiting of any animal; or shall keep, use, manage, or act or assist in the management of, any premises or place for the purpose, or partly for the purpose of fighting or baiting any animal, or shall permit any premises or place to be so kept, managed or used, or shall receive, or cause or procure any person to receive, money for the admission of any person to such premises or place”; and

(ii) by increasing the maximum period of imprisonment therein provided from three months to six months and amount of fine from twenty five pounds to five hundred pounds on a first conviction and to twelve months and one thousand pounds respectively on a second or subsequent conviction.

3. The principal Ordinance is hereby amended by adding the following new sections immediately after section 12 thereof:-

New sections 13 and 14 added to the principal Ordinance.

"Attendance at
animal fights.

"13. A person who, without reasonable excuse, is present when animals are placed together for the purpose of their fighting each other shall be guilty of an offence and liable on conviction to a fine not exceeding five hundred pounds."

Advertising of
animal fights.

"14. If a person who publishes or causes to be published an advertisement for a fight between animals knows that it is such an advertisement he shall be guilty of an offence and liable on conviction to a fine not exceeding five hundred pounds."

TO AMEND THE MARRIAGE ORDINANCE**

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:-

1. This Ordinance may be cited as the Marriage (Amendment) Ordinance 1999 and shall be read as one with the Marriage Ordinance, as amended from time to time (hereinafter referred to as "the principal Ordinance").

Short title.
Cap.279 (Laws of Cyprus) and Ordinances 4/62, 1/64, 1/70, 2/80, 7/86, 12/90 and 6/99.

2. The principal Ordinance is hereby amended by repealing the Second Schedule thereto and substituting therefor the following new Schedule:

**AN ORDINANCE
TO AMEND THE BIRTHS AND DEATHS
REGISTRATION ORDINANCE**

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:-

Short title.

1. This Ordinance may be cited as the Births and Deaths Registration (Amendment) Ordinance 1999 and shall be read as one with the Births and Deaths Registration Ordinance 1975 (hereinafter referred to as "the principal Ordinance").

Ordinances 8 of 1975 and 6 of 1992.

Section 10 of the principal Ordinance amended.

2. Section 10 of the principal Ordinance is hereby amended by deleting the words "three pounds" appearing in the second line of subsection (4) thereof and substituting therefor the words "five pounds".

Section 11 of the principal Ordinance amended.

3. Section 11 of the principal Ordinance is hereby amended by deleting the words "ten pounds" appearing in the second line of subsection (2) thereof and substituting therefor the words "fifteen pounds".

Section 16 of the principal Ordinance amended.

4. Section 16 of the principal Ordinance is hereby amended by deleting the words "one pound" appearing in the sixteenth line thereof and substituting therefor the words "ten pounds".

Section 24 of the principal Ordinance amended.

5. Section 24 of the principal Ordinance is hereby amended by deleting the words "ten pounds" appearing in the third line of subsection (2) thereof and substituting therefor the words "fifteen pounds".

Section 32 of the principal Ordinance amended.

6. Section 32 of the principal Ordinance is hereby amended by deleting the words "three pounds" appearing in the fifth line of subsection (3) thereof and substituting therefor the words "five pounds".
