ORDINANCE 16 OF 1999

AN ORDINANCE
TO AMEND THE FACTORIES ORDINANCE

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:-

1. This Ordinance may be cited as the Factories (Amendment) Ordinance 1999 and shall be read as one with the Factories Ordinance as amended from time to time (hereinafter referred to as “the principal Ordinance”).

Short title.
Cap.134 (Laws of Cyprus) and Ordinances 22/64, 12/72, 9/82, 15/89, 7/90 and 7/92.

2. Section 3 of the principal Ordinance is hereby amended as follows:-

Section 3 of the principal Ordinance amended.

(a) By repealing the definition of the term “Chief Inspector” appearing therein and substituting therefor the following new definition:

““Chief Inspector” means a person appointed in accordance with section 40 of the Health and Safety at Work Ordinance”;

(b) By repealing the definition of the term “Inspector” appearing therein and substituting therefor the following new definition:

““Inspector” has the same meaning as in section 2 of the Health and Safety at Work Ordinance.”.

3. Sections 7, 12, 13, 14, 18, 19, 20, 21, 22, 32, 36 and 37 of the principal Ordinance are hereby repealed.

6. Sections 46A, 47, 48, 49, 50, 53, 55, 60, 61, 62, 64, 65, 78, 79, 80, 82 and 84 of the principal Ordinance are hereby repealed.

7. Sections 87, 89, 91 and 92 of the principal Ordinance are hereby repealed.

8. Subsections (2) and (3) of section 107 of the principal Ordinance are hereby repealed.
