ORDINANCE 7 OF 2000

**AN ORDINANCE**  
**TO AMEND THE PROTECTION OF MATERNITY**  
**ORDINANCE**

**BE** it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:-

1. This Ordinance may be cited as the Protection of Maternity (Amendment) Ordinance 2000 and shall be read as one with the Protection of Maternity Ordinance (hereinafter referred to as "the principal Ordinance").

Short title.

Ordinance 21 of 1999.

2. Section 3 of the principal Ordinance is hereby amended by deleting the word "five" appearing in line two of subsection (3) thereof and substituting therefor the word "twelve".

ORDINANCE 8 OF 2000

**AN ORDINANCE  
TO AMEND THE ESTATE DUTY ORDINANCE**

**BE** it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:-

Short title.

amended.

1. This Ordinance may be cited as the Estate Duty (Amendment) Ordinance 2000 and shall be read as one with the Estate Duty Ordinance 1965 as amended from time to time (hereinafter referred to as "the principal Ordinance").

2. The principal Ordinance is hereby amended by adding at the end of section 6 thereof the following proviso:

"Provided that estate duty shall cease to be payable upon the value of the estate of any person dying on or after 1st January 2000."

ORDINANCE 9 OF 2000

**AN ORDINANCE  
TO AMEND THE CHILDREN AND YOUNG PERSONS  
(EMPLOYMENT) ORDINANCE**

2nd August 2000.

**BE** it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:-

1. This Ordinance may be cited as the Children and Young Persons (Employment) Amendment Ordinance 2000 and shall be read as one with the Children and Young Persons (Employment) Ordinance, as amended from time to time (hereinafter referred to as “the principal Ordinance”).

Short title.

Cap. 178 (Laws of Cyprus), and Ordinances 1/65, 3/68 and 6/91.

2. The principal Ordinance is hereby amended by repealing section 3 thereof and substituting therefor the following new section:

Section 3 of the principal Ordinance repealed and substituted.

“Restrictions on employment and minimum age.

3.- (1) No child shall be employed in any occupation unless he has attained the age of 15 years.

(2)(a) No child shall be employed in an industrial undertaking.

(b) Subject to the provisions of this Ordinance a child of at least 15 years of age may be indentured as an apprentice for the purpose of learning a vocation or trade, to any person who is in possession of a specific licence therefor, issued by the Chief Officer.

(3) The occupation or employment of any child or young person in any work carried on underground or in a mine is hereby prohibited.”

3. The principal Ordinance is hereby amended by repealing section 4 thereof and substituting therefor the following new section:

Section 4 of the principal Ordinance repealed and substituted.

“Hours of work and rest with respect to children.

“ 4.- (1) No child shall be employed in any undertaking for more than thirty six hours in any one week or for more than seven and a quarter hours in any one day.

(2) No child shall be employed in any undertaking for a continuous period of more than four and a half hours without an interval of at least half an hour for a meal or rest.

(3) No child who has attained the age of 15 years and who is attending educational evening classes shall be employed after 4 p.m. on the days he attends such classes.

(4) Any child who is employed in any undertaking shall be allowed –

- (i) each week, a continuous period of rest of at least thirty six hours;
- (ii) each day, a continuous period of rest of at least fourteen hours.”.

Section 5 of the principal Ordinance amended.

5. Section 5 of the principal Ordinance is hereby amended by inserting immediately after subsection (4) thereof the following new subsection (5):

“(5) A young person employed in any undertaking shall be allowed a continuous period of rest of at least twelve hours each day.”.

Section 8 of the principal Ordinance repealed and substituted.

6. The principal Ordinance is hereby amended by repealing section 8 thereof and substituting therefor the following new section:

“Restrictions on employment of young persons at night.

8.- (1) No young person shall be employed in any undertaking between the hours of 10 p.m. one day and 7 a.m. the following day:

Provided that the young person may be occupied or employed during the night for purposes of art, science or education during any public show, in accordance with the conditions of a relevant licence issued by the Chief Officer who may at any time suspend or cancel the conditions of such licence.”.

ORDINANCE 10 OF 2000

**AN ORDINANCE  
TO AMEND THE STREETS AND BUILDINGS  
REGULATION (CONSOLIDATION) ORDINANCE 1984**

9th August 2000.

**BE** it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:

1. This Ordinance may be cited as the Streets and Buildings Regulation (Consolidation) (Amendment) Ordinance 2000 and shall be read as one with the Streets and Buildings Regulation (Consolidation) Ordinance 1984 as amended from time to time (hereinafter referred to as “the principal Ordinance”).

Short title.

Ordinances 7/84, 2/87, 13/87, 18/88, 10/96, 7/99 and 2/2000.

2. Section 10 of the principal Ordinance is hereby amended:-

Section 10 of the principal Ordinance amended.

(a) by inserting immediately after sub-paragraph (xii) of paragraph (a) of subsection (1) thereof the following new sub-paragraph to be numbered (xiii):

“(xiii) the construction of sewage waste connections to any main sewage waste systems.”;

(b) by inserting immediately after sub-paragraph (xiii) of paragraph (c) of subsection (1) thereof the following new sub-paragraph to be numbered (xiv):

“(xiv) the construction of a sewage system, where appropriate.”.

3. The principal Ordinance is hereby amended by inserting immediately after section 19 thereof the following new section 19A:-

Special provisions inserted in the principal Ordinance.

“19A. Notwithstanding any other provision of this Ordinance or of any regulations made thereunder, the height of any wall or parapet required to be erected on the roof of any building for the protection of persons who gain access thereto by means of any staircase, or which is required to be erected for any reason at ground level, shall be not less than 1.10 metres.

4. Subsection (1) of section 22 of the principal Ordinance is hereby amended by adding to the end of paragraph (I) the following words:-

“and to provide for the special needs of disabled persons.”.
