ORDINANCE 14 OF 2005

AN ORDINANCE TO AMEND THE PRISONS ORDINANCE 1971

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:—

1. This Ordinance may be cited as the Prisons (Amendment) Ordinance 2005.

Short Title.

Ordinance 11 of 1971 as amended by Ordinance 2 of 1985.

- **2.** In this Ordinance the "principal Ordinance" means the Prisons Ordinance 1971.
- Definition.
- **3.** Section 2 of the principal Ordinance is amended by inserting the following new definition in its appropriate alphabetical place—

Amendment to section 2 of the principal Ordinance.

""adjudicator" means a person approved by the Chief Officer for the purpose of inquiring into a charge which has been referred to him;".

4. Section 9 of the principal Ordinance is amended by—

Amendment to section 9 of the principal Ordinance.

- (a) in subsection (1)(viii) inserting after the word "proceedings" the words "including whether such proceedings are to be dealt with by the Superintendent or by an adjudicator";
- (b) by deleting the full stop at the end of paragraph (xiii) of subsection (1) and replacing it with a semi-colon;
- (c) by inserting a new paragraph immediately after paragraph (xiii) of subsection (1) as follows
 - "(xiv) for the powers which may be exercised by an adjudicator.";
- (d) by deleting subsection (2) and replacing it with the following
 - "(2) Regulations made under this section may provide for the following punishments to be awarded to prisoners –

- (a) a caution;
- (b) cellular confinement for a period not exceeding 12 days;
- (c) suspension of privilege of smoking during the period of cellular confinement;
- (d) forfeiture of allowances for compensating any damage caused to prison property;
- (e) suspension of visits for a period not exceeding 1 month;
- (f) suspension of the right to send and receive letters for a period not exceeding 1 month;
- (g) forfeiture of remission not exceeding 90 days.".
- **5.** Section 11 of the principal Ordinance is amended by deleting subsection (3) and replacing it with the following—
 - "(3) Any regulations made under this section may provide for the following punishments for any prison officer for breach of any regulations applicable to prison officers
 - (a) dismissal;
 - (b) requirement to resign;
 - (c) reduction in rank;
 - (d) withholding, withdrawing or postponing yearly increments of pay;
 - (e) a fine not exceeding 20 days pay;
 - (f) severe reprimand;
 - (g) reprimand;
 - (h) admonition.".
