MOTOR VEHICLES AND ROAD TRAFFIC (CONSOLIDATION) (AMENDMENT)
ORDINANCE 2008

An Ordinance to amend the Motor Vehicles and Road Traffic Ordinance 2006 and for related matters

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:—

1. Short title

This Ordinance may be cited as the Motor Vehicles and Road Traffic (Consolidation) (Amendment) Ordinance 2008.

2. Amendment of the Motor Vehicles and Road Traffic (Consolidation) Ordinance 2006

Section 33(a) of the Motor Vehicles and Road Traffic (Consolidation) Ordinance 2006(a) is deleted and substituted as follows—

“(a) points must be imposed only in respect of the offences listed in paragraphs 1, 2, 6, 9, 10, 11, 12 and 13 of the Schedule;”.

3. Commencement

This Ordinance comes into force on the day it is published in the Gazette.

EXPLANATORY NOTE

(This note does not form part of the Ordinance)

Introduction

1. These explanatory notes relate to the Motor Vehicles and Road Traffic (Consolidation) (Amendment) Ordinance 2008 (the “Ordinance”). They have been prepared by the Office of the Attorney General and Legal Adviser in order to assist the reader of the Ordinance. They do not form part of the Ordinance.

2. The notes should be read in conjunction with the Ordinance. They are not, and are not meant to be, a comprehensive description of the Ordinance. So when a section or part of a section does not seem to require any explanation or comment, none is given.

The Ordinance

3. Section 3 of the Ordinance amends section 33(a) of the Motor Vehicles and Road Traffic Ordinance 2006 by deleting reference to the police having the power to impose penalty points only in respect of offences listed in the Second Schedule of the Fixed Penalty Ordinance 1998.
