**PROTECTION OF PUBLIC HEALTH (COVID-19)
(AMENDMENT NO.13) ORDINANCE 2021**

An Ordinance to amend the Protection of Public Health (Covid-19) Ordinance 2021.

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:—

Short title and commencement

1.—(1) This Ordinance may be cited as the Protection of Public Health (Covid-19) (Amendment No.13) Ordinance 2021.

(2) This Ordinance comes into force at 5:00am on 29 May 2021.

Amendment of the Protection of Public Health (Covid-19) Ordinance 2021

2.—(1) The Protection of Public Health (Covid-19) Ordinance 2021(a) is amended as follows.

(a) Ordinance 2/2021, amended by Ordinances 5/2021, 7/2021, 8/2021, 9/2021, 10/2021, 11/2021, 14/2021, 15/2021, 16/2021, 17/2021, 18/2021 and 19/2021.

- (2) In section 6 (curfew)—
- (a) for the heading substitute “Prohibition on movement of people between 1am and 5am”,
 - (b) in subsection (1) for “midnight” substitute “1am”,
 - (c) in subsection (2)—
 - (i) for “midnight” substitute “1am”,
 - (ii) in paragraph (c) delete the final ‘or’,
 - (iii) in paragraph (d) for “themselves.” substitute “themselves, or”,
 - (iv) after paragraph (d), insert—
 - “(e) on 30 May 2021, P is travelling for the purposes of the parliamentary elections in the Republic.”
 - (d) in subsection (3) for “midnight” substitute “1am”.
- (3) In section 13 (measures relating to businesses) omit subsection (10).

EXPLANATORY NOTE

(This note is not part of the Ordinance)

1. This explanatory note relates to the Protection of Public Health (Covid-19) (Amendment No.13) Ordinance 2021 ("the Ordinance"). It has been prepared by the Office of the Attorney General and Legal Adviser in order to assist the reader of the Ordinance. It does not form part of the Ordinance.
2. The amendments are intended to mirror certain provisions of the Quarantine (Determination of Measures for the Prevention of the Spread of Corona Virus Covid-19) Order (No.18) of 2021 (P.I. 209/2021) and the Quarantine (Determination of Measures for the Prevention of the Spread of Corona Virus Covid-19) Order (No.19) of 2021 (P.I. 226/2021) of the Republic.
3. Section 2 amends the Protection of Public Health (Covid-19) Ordinance 2021 ("the principal Ordinance").
4. Subsection (2) amends the curfew hours in the principal ordinance to between 1am and 5am and allows for persons to travel on the 30 May 2021 for the purpose of the parliamentary elections in the Republic of Cyprus.
5. Subsection (3) removes the restriction in the principal ordinance on the number of persons able to be present at a private institute or private education centre.
