An Ordinance to amend the Fixed Penalty Ordinance 2010.

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:—

Citation and commencement

- 1.—(1) This Ordinance may be cited as the Fixed Penalty (Amendment) Ordinance 2024.
- (2) This Ordinance comes into force on 13 February 2024.

Amendment of the Fixed Penalty Ordinance 2010

- 2.—(1) Schedule 2 to the Fixed Penalty Ordinance 2010(a) is amended as follows.
- (2) For serial number 154, substitute—

EXPLANATORY NOTE

1. This explanatory note relates to the Fixed Penalty (Amendment) Ordinance 2024 (“the Ordinance”). It has been prepared by the Office of the Attorney General and Legal Adviser in order to assist the reader of the Ordinance. It does not form part of the Ordinance.

2. Section 2 of the Ordinance substitutes, in the table in Schedule 2 to the Fixed Penalty Ordinance 2010, serial numbers 154 and 156 to 160. These relate to breaches of a variety of requirements of the Protection of Public Health (Covid-19) Ordinance 2024.
