THE MOTOR VEHICLES (THIRD PARTY INSURANCE)  
ORDINANCE

(Cap. 333 and 7 of 1960 - Laws of Cyprus).

ORDER UNDER SECTION 2.

In exercise of the powers vested in him by Section 2 of the Motor Vehicles (Third Party Insurance) Ordinance, the Administrator has been pleased to make the following Order:-
