**THE GAME AND WILD BIRDS PROTECTION
ORDINANCE.**

ORDER MADE UNDER SECTIONS 2 AND 3.

Cap. 65
(Laws of
Cyprus)
and Ordinances
19 of 1961
and 17 of 1962.

In exercise of the powers vested in him by sections 2 and 3 of the Game and Wild Birds Protection Ordinance, the Administrator has been pleased to prescribe that the periods specified in the Schedule hereto shall be a close season in addition to the close season as defined in section 2 of the Ordinance.

SCHEDULE

- (a) The period between 1st October, 1962 and 20th October, 1962, both days inclusive.
- (b) The period between the 14th January, 1963 and 31st January, 1963, both days inclusive.
- (c) All days in the week during a non-close season except Wednesdays and Sundays.

2. This Order shall be deemed to have come into operation on 1st October, 1962.

REGULATIONS, 1956 to 1959.

THE MOTOR VEHICLES (THIRD PARTY INSURANCE)
ORDINANCE.

(Cap. 333 and 7 of 1960 - Laws of Cyprus).

ORDER UNDER SECTION 2.

In exercise of the powers vested in him by section 2 of the Motor Vehicles (Third Party Insurance) Ordinance, the Administrator has been pleased to make the following Order:—

1. This Order may be cited as the Motor Vehicles (Third Party Insurers) (Amendment) Order, 1962, and shall be read as one with the Motor Vehicles (Third Party Insurers) Order, 1957, as amended from time to time (hereinafter referred to as "the principal Order").

2. The principal Order is hereby amended by the addition of the following Insurance Companies to the Schedule thereto:—

The Anadolu Anonim Türk Sigorta Şirketi of İstanbul,
Güneş Sigorta A.S. of İstanbul.

3. This Order shall be deemed to have come into operation on 20th September, 1962.
