NOTICE UNDER REGULATION 20 (b).

PACKING SPECIFICATIONS FOR PERISHABLES.

---

In exercise of the powers conferred upon me by paragraph (b) of Regulation 20 of the Agricultural Produce (Export) Regulations, 1956 to 1959, as applied to and adapted in the Areas by the Laws (Adaptation and Interpretation) Ordinance, 1960 to 1962, I, the Acting Chief Officer, Sovereign Base Areas hereby order as follows:-

1. Every case of any type containing potatoes intended for export to any destination shall have affixed externally a wooden bar extending along the whole width of the case at each end, at the bottom of such case. The thickness of the wooden bars shall be 7 m.m. and their width 50 m.m.
2. The above specification is in addition to the Packing Specifications for Perishables published under Notification No. 422 in Supplement No. 3 to the Republican Gazette of the 3rd September, 1959.
3. This Order shall be deemed to have come into operation on 10th September, 1963.

**THE GAME AND WILD BIRDS PROTECTION  
ORDINANCE.**

**ORDER MADE UNDER SECTIONS 2 AND 3.**

In exercise of the powers vested in him by sections 2 and 3 of the Game and Wild Birds Protection Ordinance, the Administrator has been pleased to prescribe that the periods specified in the Schedule hereto shall be a close season in addition to the close season as defined in section 2 of the Ordinance.

**SCHEDULE**

- (a) The period between 1st October, 1963 and 19th October, 1963, both days inclusive.
- (b) The period between the 13th January, 1964 and 31st January, 1964, both days inclusive.
- (c) All days in the week during a non-close season except Wednesdays and Sundays.

2. This Order shall be deemed to have come into operation on 1st October, 1963.

## NOTIFICATION UNDER SECTION 7.

Whereas by Public Instrument No. 22 of 1963, published in Supplement No. 3 to the Gazette No. 66 of 19th June, 1963, the Administrator declared the establishment of two wireless stations west of the Salt Lake and within the village of Akrotiri, to be an undertaking of public utility;

And whereas the Area Officer Akrotiri, in compliance with sub-section (1) of Section 6 of the Land Acquisition Ordinance, by Public Instrument No. 52 of 1963 gave particulars of the rights required in connection with the first of the two wireless stations (hereinafter referred to as "the rights");

And whereas the Area Officer Akrotiri, in compliance with sub-section (2) of the said section, forwarded to the Administrator the required recommendations, plan and particulars, together with the objections made;

And whereas, having considered the objections made thereto, the Administrator has approved the plan and particulars submitted, and has considered it expedient, having regard to the circumstances of the case, that the rights be acquired:

Now, therefore, in exercise of the powers vested in him by Section 7 of the Land Acquisition Ordinance, the Administrator hereby sanctions the acquisition of the rights under the provisions of the said Ordinance.
