(Cap. 199 - Laws of Cyprus).

ORDER MADE UNDER SECTION 3(4)(b).

In exercise of the powers conferred upon him by sub-section (4) (b) of section 3 of the Exchange Control Ordinance, the Fiscal Officer hereby makes the following Order:-

- 1. This order may be cited as the Exchange Control (Scheduled Territories) Order, 1964.

THE POWERS AND DUTIES (OFFICERS OF THE REPUBLIC OF CYPRUS) ORDINANCE, 1960 AND 1961.

ORDER MADE UNDER SECTION 9.

Ordinances 2 of 1960 and 3 of 1961. In exercise of the powers conferred upon him by Section 9 of the Powers and Duties (Officers of the Republic of Cyprus) Ordinance, and of all other powers enabling him in that behalf, the Administrator hereby makes the following Order:-

- 1. This Order may by cited as the Powers and Duties (Officers of the Republic of Cyprus) (Amendment of Schedule) Order, 1964.

THE POWERS AND DUTIES (OFFICERS OF THE REPUBLIC OF CYPRUS) ORDINANCE, 1960 AND 1961.

ORDER MADE UNDER SECTION 3.

In exercise of the powers conferred upon him by Section 3 of the Powers and Duties (Officers of the Republic of Cyprus) Ordinance and of all other powers enabling him in that behalf, the Administrator hereby makes the following Order:-

1. This Order may be cited as the Powers and Duties

Ordinances 2 of 1960 and 3 of 1961. (Officers of the Republic of Cyprus) (Amendment) Order, 1964, and shall be read as one with the Powers and Duties (Officers of the Republic of Cyprus) (Amendment) Order, 1960 as amended by the Powers and Duties (Officers of the Republic of Cyprus) (Amendment) Order, 1961 and 1963 hereinafter referred to as "the principal Order").

2. Part I of the Schedule of the principal Order is amended by adding under the appropriate columns the following items:-
