THE EXCHANGE CONTROL ORDINANCE

(Cap. 199 - Laws of Cyprus).

ORDER MADE UNDER SECTION 3(4)(b).

In exercise of the powers conferred upon him by subsection (4) (b) of section 3 of the Exchange Control Ordinance, the Fiscal Officer hereby makes the following Order:-

1. This Order may be cited as the Exchange Control (Scheduled Territories) Order, 1966.

2. The First Schedule to the Exchange Control Ordinance shall be amended to read as set out in the Schedule to this Order.
