**THE POWERS AND DUTIES (OFFICERS
OF THE REPUBLIC OF CYPRUS) ORDINANCE**

(Ordinances 2 of 1960, 3 of 1961 and 19 of 1966)

ORDER MADE UNDER SECTION 9.

In exercise of the powers conferred upon him by Section 9 of the Powers and Duties (Officers of the Republic of Cyprus) Ordinance, and of all other powers enabling him in that behalf, the Administrator hereby makes the following Order:—

1. This Order may be cited as the Powers and Duties (Officers of the Republic of Cyprus) (Amendment of Schedule) (No. 2) Order, 1967, and shall be read as one with the Powers and Duties (Officers of the Republic of Cyprus) Order, as amended from time to time.

ORDER MADE UNDER SECTION 3.

In exercise of the powers conferred upon him by Section 3 of the Powers and Duties (Officers of the Republic of Cyprus) Ordinance, and of all other powers enabling him in that behalf, the Administrator hereby makes the following Order:—

1. This Order may be cited as the Powers and Duties (Officers of the Republic of Cyprus) (Amendment) (No. 2) Order, 1967, and shall be read as one with the Powers and Duties (Officers of the Republic of Cyprus) Order as amended from time to time (hereinafter referred to as "the principal Order").
