THE GAME AND WILD BIRDS PROTECTION  
ORDINANCE

(Cap 65 - Laws of Cyprus - and Ordinances  
19 of 1961, 17 of 1962, 19 of 1964 and 6 of 1966.)

ORDER MADE UNDER SECTION 15.

---

In exercise of the powers conferred upon him by section 15 of the Game and Wild Birds Protection Ordinance, the Administrator hereby suspends the operation of paragraphs (a) and (b) of that section in respect of wild duck shot, killed, taken or pursued in the area known as the Limassol Salt Lake Marshes, which is more specifically marked on a plan deposited at the Area Office Akrotiri (Series K817, Sheet 58, Edition 5 - GSGS), subject to the condition that this suspension shall not extend beyond three hours after sunset and one hour before sunrise.

NOTICE UNDER SECTIONS 2, 3 and 5.

Whereas it has been represented to the Administrator's Deputy that it is desirable for public purposes to realign and widen the Limassol-Paphos trunk road, in so far as it lies within the Akrotiri Sovereign Base Area, the cost whereof is to be borne by the Sovereign Base Areas Administration:

Now, therefore, in exercise of the powers vested in him by sections 2, 3 and 5 of the Land Acquisition Ordinance, the Administrator's Deputy does hereby declare the realignment and widening of the aforesaid road to be an undertaking of public utility and does hereby entrust the supervision and effectuation of the said undertaking to the Regional Director, Ministry of Public Building and Works and to the Defence Land Agent (Near East).

## NOTICE UNDER SECTION 6.
