**ORDER MADE UNDER SECTIONS 2 AND 3.**

---

In exercise of the powers vested in him by sections 2 and 3 of the Game and Wild Birds Protection Ordinance, the Administrator has been pleased to prescribe that the periods specified in the Schedule hereto shall be a close season in addition to the close season as defined in section 2 of the Ordinance.

---

**SCHEDULE**

- a. The period between 1st October 1968 and 19th October 1968, both days inclusive.
  - b. The period between the 13th January 1969 and 31st January 1969, both days inclusive.
  - c. All days in the week during a non-close season except Wednesdays and Sundays.
