ORDER MADE UNDER SECTION 3(4)(b)

In exercise of the powers conferred upon him by sub-section (4)(b) of section 3 of the Exchange Control Ordinance, the Fiscal Officer hereby makes the following Order:—

1. This Order may be cited as the Exchange Control (Scheduled Territories) Order, 1968.

2. The First Schedule to the Exchange Control Ordinance shall be amended to read as set out in the Schedule to this Order.

THE GAME AND WILD BIRDS PROTECTION  
ORDINANCE

(Cap. 65 - Laws of Cyprus and Ordinances 19 of 1961,  
17 of 1962, 19 of 1964 and 6 of 1966).

ORDER UNDER SECTION 5A

---

In exercise of the powers conferred upon me under section 5A of the Game and Wild Birds Protection Ordinance, I, the Chief Officer, hereby order as follows:—

1. This Order may be cited as the Game and Wild Birds Protection (Maximum Number of Game Shot) Order, 1968.

2. The number of game that may be shot by the holder of a game licence on any one day shall not exceed two hares and six partridges or two hares, four partridges and two francolins.
