## THE GAME AND WILD BIRDS PROTECTION ORDINANCE

(Cap. 65—Laws of Cyprus—and Ordinances 19 of 1961,  
17 of 1962, 19 of 1964 and 6 of 1966).

ORDER MADE UNDER SECTIONS 2 AND 3.

---

In exercise of the powers vested in him by Sections 2 and 3 of the Game and Wild Birds Protection Ordinance, the Administrator hereby amends the Order published in the Gazette as Public Instrument No. 46 of 1970 :

- (a) by adding at the end of paragraph (a) of the Schedule thereto the following new paragraph, to be lettered (aa) :

“(aa) The period between 23rd December, 1970 and 10th January, 1971, both days inclusive, in relation to partridges and francolins.”;

- (b) by deleting paragraph (c) of the Schedule thereto and substituting therefor the following paragraph :

“(c) All days in the week during a non-close season—

- (i) except Sundays in every week in relation to any game other than partridges and francolins as provided in paragraph (aa) of this Schedule ; and
- (ii) except Wednesdays in every week between 23rd December, 1970 and 10th January, 1971, both days inclusive, in relation to hares.”.

THE COMMODITIES AND SERVICES  
(REGULATION AND CONTROL) ORDINANCE

(Ordinances 11 of 1962, 9 of 1963 and 3 of 1967).

CONTROL AND MAXIMUM PRICE ORDER  
MADE UNDER SECTIONS 3 (1) AND 4.

---

In exercise of the powers vested in him by subsection (1) of sections 3 and 4 of the Commodities and Services (Regulation and Control) Ordinance, the Administrator hereby makes the following Order :—

1. This Order may be cited as the Commodities and Services (Regulation and Control) (Maximum Price of Bananas) Order, 1970.

2. In this Order—

“bananas” means bananas declared to be a controlled commodity under the Commodities and Services (Regulation and Control) (Maximum Percentage of Profit) (Perishable Goods) Order, 1969.

P.I. No. 23/69.

3. The maximum price at which bananas may be sold by retail in the Areas shall not exceed two hundred and seventy-five (275) mils per oke.

4. The Schedule to the Commodities and Services (Regulation and Control) (Maximum Percentage of Profit) (Perishable Goods) Order, 1969, is hereby amended by deleting Item 32 thereof relating to bananas.
