THE CONTAGIOUS DISEASES (ANIMALS) ORDINANCE
(Cap. 45 and Law No. 17 of 1959 - Laws of Cyprus - and
Ordinances 3 and 6 of 1969).

ORDER UNDER SECTION 4 (1) (k) AND (l).

In exercise of the powers vested in him by paragraphs (k) and (l) of subsection (1) of Section 4 of the Contagious Diseases (Animals) Ordinance, the Administrator hereby makes the following Order :—

1. This Order may be cited as the Importation of Parrots (Prohibition) Order, 1971.
2. The importation into the Areas of parrots and other birds of the species psittaciformes is hereby prohibited.

THE GAME AND WILD BIRDS PROTECTION
ORDINANCE

(Cap. 65 - Laws of Cyprus - and Ordinances 19 of 1961,
17 of 1962, 19 of 1964 and 6 of 1966).

ORDER MADE UNDER SECTION 16.

In exercise of the powers vested in him by the proviso to sub-section (1) of Section 16 of the Game and Wild Birds Protection Ordinance, the Chief Officer, hereby orders that the shooting, killing, taking, pursuing, selling or exposing for sale of the following wild birds shall be prohibited for a period of two years commencing from the promulgation of this Order :—

1. All birds of the family Falconidae, namely all birds of prey such as eagles, hawks, falcons and vultures.
2. All birds of the family Strigidae, namely owls of all species.
3. All birds of the family Laridae, namely all species of gulls.
4. All large aquatic birds such as Herons, Storks, Ibises, Spoonbills, Cranes, Pelicans, Cormorants and Shags, other than Ducks and Geese.
5. Black-bellied sandgrouse, (*Pterocles orientalis orientalis*).
6. Hoopoe, (*Upupa epops epops*).
7. Golden oriole, (*Oriolus oriolus oriolus*).
8. European Kingfisher, (*Alcedo atthis atthis*).
