THE LAWS (ADAPTATION AND INTERPRETATION)
(CONSOLIDATION AND EXTENSION) ORDINANCE, 1968

(Ordinance 5 of 1968).

ORDER MADE BY THE ADMINISTRATOR
UNDER SUB-SECTION (3) OF SECTION 4.

In exercise of the powers conferred upon him by sub-section (3) of Section 4 of the Laws (Adaptation and Interpretation) (Consolidation and Extension) Ordinance, 1968, and of all other powers enabling him in that behalf, the Administrator hereby makes the following Order:—

1. This Order may be cited as the Laws (Adaptation and Interpretation) (Amendment of Schedule) Order, 1972.

2. The First Schedule to the Laws (Adaptation and Interpretation) (Consolidation and Extension) Ordinance, 1968 is hereby amended by the addition thereto, immediately after the reference to Cap. 147 (Tobacco Ordinance), under the appropriate columns, of the following:—

THE GAME AND WILD BIRDS PROTECTION
ORDINANCE

(Cap. 65 — Laws of Cyprus and Ordinances
19 of 1961, 17 of 1962, 19 of 1964 and 6 of 1966).

ORDER MADE UNDER SECTIONS 2 AND 3.

In exercise of the powers vested in him by sections 2 and 3 of the Game and Wild Birds Protection Ordinance, the Administrator has prescribed that the periods specified in the Schedule hereto shall be a close season in addition to the close season as defined in section 2 of the Ordinance.

SCHEDULE

- (a) The period between 1st October, 1972 and 4th November, 1972, both days inclusive.
 - (b) The period between 1st January, 1973 and 31st January, 1973, both days inclusive.
 - (c) All days in the week during a non - close season except Wednesdays and Sundays.

THE GAME AND WILD BIRDS PROTECTION
ORDINANCE

(Cap. 65 — Laws of Cyprus and Ordinances
19 of 1961, 17 of 1962, 19 of 1964 and 6 of 1966).

ORDER MADE UNDER SECTION 5A.

In exercise of the powers conferred upon the Chief Officer under section 5A of the Game and Wild Birds Protection Ordinance, I, the Acting Chief Officer, hereby order as follows :—

1. This Order may be cited as the Game and Wild Birds Protection (Maximum Number of Game) Order, 1972.
 2. The number of game that may be shot by the holder of a game licence on any one day shall not exceed one hare and six partridges or one hare, five partridges and one francolin.
