**THE GAME AND WILD BIRDS PROTECTION  
ORDINANCE**

(Cap. 65 — Laws of Cyprus — and Ordinances 19 of 1961,  
17 of 1962, 19 of 1964 and 6 of 1966).

ORDER MADE UNDER SECTIONS 2 AND 3.

In exercise of the powers vested in him by Sections 2 and 3 of the Game and Wild Birds Protection Ordinance, the Administrator hereby amends the Order published in the Gazette of 11th October, 1972 as Public Instrument No. 35 —

- (a) by adding at the end of paragraph (a) of the Schedule thereto the following new paragraph, to be lettered (aa):
- “(aa) The period between 6th December, 1972 and 31st December 1972, both days inclusive, in relation to hares, partridges and francolins.”;
- (b) by deleting paragraph (c) of the Schedule thereto and substituting therefor the following paragraph:
- “(c) All days in the week during a non-close season except Wednesdays and Sundays in relation to any game other than hares, partridges and francolins as provided in paragraph (aa) of this Schedule.”.

(REGULATION AND CONTROL) ORDINANCE

(Ordinances 11 of 1962, 9 of 1963, 3 of 1967 and 10 of 1972).

CONTROL AND MAXIMUM PRICE  
ORDER MADE UNDER SECTIONS 3 (1) AND 4.

In exercise of the powers vested in him by sub-section (1) of sections 3 and 4 of the Commodities and Services (Regulation and Control) Ordinance, the Administrator hereby makes the following Order :—

1. This Order may be cited as the Commodities and Services (Regulation and Control) (Maximum Price of Bananas) Order, 1972.

2. In this Order—

“bananas” means bananas declared to be a controlled commodity under the Commodities and Services (Regulation and Control) (Maximum Percentage of Profit) (Perishable Goods) Order, 1969.

3. The maximum price at which bananas may be sold by retail in the Areas shall not exceed two hundred and seventy-five (275) mils per oke.

4. Public Instrument No. 16 of 1972 is hereby revoked.

CONTROL AND MAXIMUM PRICE  
ORDER MADE UNDER SECTIONS 3 (1) AND 4.

In exercise of the powers vested in him by sub-section (1) of sections 3 and 4 of the Commodities and Services (Regulation and Control) Ordinance, the Administrator hereby makes the following Order :—

1. This Order may be cited as the Commodities and Services (Regulation and Control) (Maximum Price) (No. 3) Order, 1972.
  2. Eggs are hereby declared to be a controlled commodity for the purpose of the Ordinance.
  3. The maximum price at which eggs may be sold by retail in the Areas shall not exceed two hundred and fifty mils per dozen.
