## THE PRISONS ORDINANCE, 1971

(Ordinance 11 of 1971).

## THE POLICE ORDINANCE, 1967

(Ordinances 9 of 1967, 14 of 1969 and 7 of 1975).

REGULATIONS MADE UNDER SUBSECTION (2) OF SECTION  
15 OF THE PRISONS ORDINANCE, 1971, READ WITH SECTION  
11 OF THE PRISONS ORDINANCE AND WITH SECTION 9 OF  
THE POLICE ORDINANCE.

In exercise of the powers vested in me by subsection (2) of section 15 of the Prisons Ordinance, 1971, read with section 11 of that Ordinance and with section 9 of the Police Ordinance, 1967, I, the Superintendent of Prisons and the Chief Police Officer, with the approval of the Administrator, hereby make the following Regulations :

1. These Regulations may be cited as the Police and Prisons Officers' (Pensions) (Amendment) Regulations, 1975 and shall be read as one with the Police and Prisons Officers' (Pensions) Regulations, 1975 (hereinafter referred to as "the principal Regulations").

2. Regulation 4 of the principal Regulations is hereby amended by deleting the word "three" appearing in the first line of the second proviso to paragraph (1) thereof and substituting therefor the word "five".

3. Regulation 28 of the principal Regulations is hereby amended by deleting the word "three" appearing in the second line of paragraph (2) thereof and substituting therefor the word "five".

ORDER MADE UNDER SECTION 30.
