THE POWERS AND DUTIES (OFFICERS OF THE
REPUBLIC OF CYPRUS) ORDINANCE

ORDER MADE UNDER SECTION 9.

In exercise of the powers conferred upon him by Section 9 of the Powers and Duties (Officers of the Republic of Cyprus) Ordinance, and of all other powers enabling him in that behalf, the Administrator hereby makes the following Order :—

1. This Order may be cited as the Powers and Duties (Officers of the Republic of Cyprus) (Amendment of Schedule) (No. 4) Order, 1975 and shall be read as one with the Powers and Duties (Officers of the Republic of Cyprus) Order, as amended from time to time.

**THE POWERS AND DUTIES (OFFICERS OF THE
REPUBLIC OF CYPRUS) ORDINANCE**

(Ordinances 2 of 1960, 3 of 1961 and 19 of 1966).

ORDER MADE UNDER SECTION 3.

In exercise of the powers conferred upon him by Section 3 of the Powers and Duties (Officers of the Republic of Cyprus) Ordinance, and of all other powers enabling him in that behalf, the Administrator hereby makes the following Order :—

1. This Order may be cited as the Powers and Duties (Officers of the Republic of Cyprus) (Amendment) (No. 5) Order, 1975 and shall be read as one with the Powers and Duties (Officers of the Republic of Cyprus) Order, as amended from time to time (hereinafter referred to as "the principal Order").

THE GAME AND WILD BIRDS
(PROTECTION AND DEVELOPMENT) ORDINANCE

(Ordinance 11 of 1974).

NOTICE UNDER SECTION 27 (1) (b).

In exercise of the powers conferred upon him by paragraph (b) of subsection (1) of section 27 of the Game and Wild Birds (Protection and Development) Ordinance, the Area Officer Akrotiri, with the approval of the Chief Officer, hereby authorises any holder of a valid game licence to shoot, take or pursue wild birds, including such vermin as sparrows, crows, magpies, jackdaws and foxes in the areas set out in the schedule hereto during the period commencing on the 28th December 1975 and ending on the 29th February 1976, subject to the following terms and conditions:—

- (a) Shooting shall take place on Wednesdays and Sundays only;
- (b) No shooting shall take place within a radius of 150 yards from any Service installations;
- (c) No fires shall be kindled;
- (d) Between the hours of sunset and sunrise when shooting is not permitted no guns shall be carried unless they are dismantled and kept in a case;
- (e) Shot-guns shall always be carried from and to the areas specified in this Notice dismantled;
- (f) Holders of game licences shall always carry with them their game licence, their gun possession licence as well as the certificate of registration of their gun.

SCHEDULE

First Area.

The boundary commences at the junction of the earth track east of the SBA Police Station with the main Limassol - Paphos road; thence it runs northwards until it joins the Sotira earth track; thence in an easterly direction along the said track and along the SBA boundary up to the Limassol - Paphos road; thence along the said main road up to the point of commencement.

Second Area.

The boundary commences at the junction of the road running through Symboulas farm with the old Limassol - Paphos road; thence it runs northwards along the Symboulas stream up to the SBA boundary; thence along the said boundary in a westerly

direction up to Paramali Station; thence in an easterly direction along the Limassol-Paphos road up to its junction with a track east of Paramali Station; thence along the said track in a north-easterly direction up to its junction with the road running through Symboulas farm i.e. the point of commencement.
