In exercise of the powers conferred upon him by Section 3 of the Powers and Duties (Officers of the Republic of Cyprus) Ordinance, and of all other powers enabling him in that behalf, the Administrator hereby makes the following Order —

THE GAME AND WILD BIRDS
PROTECTION AND DEVELOPMENT ORDINANCE, 1974

(Ordinance 11 of 1974).

GAME RESERVE AREA ORDER.

In exercise of the powers vested in him by sub-section (1) of section 29 of the Game and Wild Birds Protection and Development Ordinance, 1974 the Administrator hereby declares the area specified in the Schedule hereto to be a Game Reserve—

SCHEDULE

All that area bounded on the north by the main road from Limassol to Paphos in so far as that road lies within the Sovereign Base Area of Akrotiri; on the east by the earth track leading to Curium beach (known as Ayios Ermoyenis road) and on the west by the Akrotiri Sovereign Base Area boundary, all of which area is more particularly shown on a map deposited at the Headquarters of the Sovereign Base Areas Administration.

2. The Public Instrument published at page 159 of S.L. Vol. I (Cyprus), in so far as it relates to Area No. 4 (Limassol District), and Public Instrument No. 3 of 1960 are hereby revoked.
