THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS) (CYPRUS) ORDER, 1946.

REVOCATION ORDER UNDER DEFENCE REGULATION 63.

In exercise of the powers vested in him by Defence Regulation 63, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946, (as applied to and adapted in the Sovereign Base Areas of Akrotiri and Dhekelia by the Sovereign Base Areas of Akrotiri and Dhekelia Order in Council, 1960 and the Laws (Adaptation and Interpretation) (Consolidation and Extension) Ordinance, 1968) which Order continues in force by virtue of the provisions of the Supplies and Services (Transitional Powers) (Continuation) Ordinance, the Administrator hereby revokes the Order published as Public

THE MOTOR VEHICLES AND ROAD TRAFFIC ORDINANCE

(Ordinance No. 8 of 1973).

REGULATIONS MADE UNDER SECTION 3 (g).

In exercise of the powers vested in him by paragraph (g) of Section 3 of the Motor Vehicles and Road Traffic Ordinance, 1973 the Administrator hereby makes the following Regulations:—

1. These Regulations may be cited as the Motor Vehicles (One Way Traffic) (Amendment) Regulations, 1976, and shall be read as one with the Motor Vehicles (One Way Traffic) Regulations, 1967, as amended from time to time (hereinafter referred to as "the principal Regulations").

P. I. Nos. 54/67, 62/67, 5/70, 13/73 and 34/75.

2. The principal Regulations are hereby amended by the addition in columns 1 and 2 respectively in Part I of the Schedule of the following:

(Ordinance No. 8 of 1973).

REGULATIONS MADE UNDER SECTION 3 (g).

In exercise of the powers vested in him by paragraph (g) of Section 3 of the Motor Vehicles and Road Traffic Ordinance, 1973 the Administrator hereby makes the following Regulations:—

- P. I. Nos. 25/61, 7/66, 51/67, 6/70, 12/73 and 35/75.
- 1. These Regulations may be cited as the Motor Vehicles (Restriction on Parking) (Amendment) Regulations, 1976 and shall be read as one with the Motor Vehicles (Restriction on Parking) Regulations, 1961, as amended from time to time (hereinafter referred to as "the principal Regulations").
 - 2. The principal Regulations are hereby amended as follows:—

In Part I of the Schedule insert under the sub-head "Royal Air Force Akrotiri" the following additional prohibited parking zone:

"The unnamed road between buildings 16 and 18a from the junction with Airfield Road to a point 40 yards West."

THE MOTOR VEHICLES AND ROAD TRAFFIC ORDINANCE

(Ordinance No. 8 of 1973).

ORDER MADE UNDER SUBSECTION (2) OF SECTION 4.

In exercise of the powers conferred upon me by Subsection (2) of Section 4 of the Motor Vehicles and Road Traffic Ordinance, 1973, I, the Chief Officer, Sovereign Base Areas, hereby make the following Order:—

- 1. This Order may be cited as the Speed Limits (Amendment) Order, 1976.
- 2. The Schedule to Public Instrument No. 24 of 1973 as amended by Public Instrument No. 36 of 1975, is hereby amended as follows:
 - (a) In Part I (i) in column 1 of paragraph (3) Royal Air Force Akrotiri insofar as it relates to Beach Road, delete "100 yards" and substitute therefor "200 yards."
 - (ii) In paragraph (9) Royal Air Force Akrotiri, and under columns 1 and 2 respectively "Stores Depot RAOC"
