THE WELLS ORDINANCE

(Cap. 351 — Laws of Cyprus — and Ordinance 6 of 1971).

ORDER MADE BY THE ADMINISTRATOR UNDER SECTION 4.

In exercise of the powers conferred upon him by Section 4 of the Wells Ordinance, the Administrator hereby defines for the purposes of the said section the area set out in the Schedule hereto as an area in which no permit for the sinking or construction of a well shall be issued and no variations or modification of any condition or restriction imposed on any such permit shall be effected, save with the concurrence of the Chief Officer, in accordance with the provisions of the said section.

2. Notice under Section 4 (2) of the Wells Ordinance in respect of this Order was published in Supplement No. 3 to Gazette No. 487 of 29th December, 1977.

3. Public Instruments Nos. 68 of 1967 and 45 of 1972 are hereby revoked.

SCHEDULE

The boundary commences at the point of the sea-shore where the boundary of the Akrotiri Sovereign Base Area commences near Boundary Pillar No. 1 and proceeds in a northerly, north-easterly and south-easterly direction along the said boundary of the said Area to a point where the said boundary is cut by the Limassol-Paphos main road, between Boundary Pillars No. 118 and 119; thence in a westerly direction along the said main road to the most western point of plot No. 127 of Survey Plan No. LVIII. 5, which point is on a road leading to the sea-shore known as the Curium beach road; thence in a south-westerly direction along the said road to the north-western corner of plot No. 24 of Survey Plan No. LVIII. 12, which corner is on the sea-shore; thence in a westerly direction along the said sea-shore to the point of commencement, all which said area is more particularly defined on the map marked Serial No. 2735.

**THE GAME AND WILD BIRDS
(PROTECTION AND DEVELOPMENT) ORDINANCE**

(Ordinance 11 of 1974).

NOTICE UNDER SECTION 27 (1) (b).

In exercise of the powers conferred upon him by paragraph (b) of sub-section (1) of Section 27 of the Game and Wild Birds (Protection and Development) Ordinance, the Area Officer Akrotiri, with the approval of the Chief Officer, hereby authorises any holder of a valid game licence to shoot, take or pursue turtle-doves, wood pigeons, and other wild birds including such vermin as sparrows, crows, magpies, jackdaws and foxes, in the area set out in the Schedule hereto during the period commencing on the 26th January 1978 and ending on the 31st March 1978, subject to the following terms and conditions :—

- (a) shooting shall take place between sunrise and sunset only ;
- (b) there shall be no shooting within 200 yards of any Service installations or within 100 yards of the perimeter of the RAF Station Akrotiri ;
- (c) no fires shall be kindled ;
- (d) there shall be no shooting within 300 yards of Akrotiri village built-up area or in any private fenced up land ;
- (e) no farm or other cultivated land where there is a risk of damage being caused to fruit trees, vegetable gardens, citrus plantations, cereal crops or vineyards shall be entered ;
- (f) hunters shall carry with them their game licence, their gun possession licence and the certificate of registration of their gun.

2. P. I. No. 47 of 1977 is hereby revoked.

SCHEDULE

All that area in the Akrotiri Sovereign Base Area which lies south of boundary pillars 266 to 242 ; thence in a westerly direction along the boundary of the Akrotiri Main State Forest up to forest cairn 17 and thence in a straight line due west as far as the coast, with the exception of any game reserves which lie within the said area.
