## THE ANTIQUITIES ORDINANCE, 1975

(Ordinance No. 12 of 1975).

ORDER MADE BY THE ADMINISTRATOR UNDER SECTION 3.

In exercise of the powers vested in him by Section 3 of the Motor Vehicles (Third Party Insurance) Ordinance, the Administrator hereby makes the following Order :—

1. This Order may be cited as the Motor Vehicles (Third Party Insurers) (Consolidation) (Amendment) (No. 2) Order, 1978 and shall be read as one with the Motor Vehicles (Third Party Insurers) (Consolidation) Order, 1978, as amended from time to time (hereinafter referred to as “the principal Order”).

THE GAME AND WILD BIRDS  
(PROTECTION AND DEVELOPMENT) ORDINANCE

(Ordinance 11 of 1974).

NOTICE UNDER SECTION 27 (1) (b).

In exercise of the powers conferred upon him by paragraph (b) of sub-section (1) of Section 27 of the Game and Wild Birds (Protection and Development) Ordinance, the Area Officer Akrotiri, with the approval of the Chief Officer, hereby authorises any holder of a valid game licence to shoot, take or pursue turtle-doves, wood pigeons, rock-pigeons, bee-eaters and other wild birds including such vermin as sparrows, crows, magpies, jackdaws and foxes, in the areas set out in the Schedule hereto during the period commencing on the 23rd April, 1978 and ending on the 14th May 1978, subject to the following terms and conditions :—

- (a) shooting shall take place between sunrise and sunset on Sundays and Wednesdays only ;
- (b) no dogs shall be used ;
- (c) no fires shall be kindled ;
- (d) no farm or other cultivated land where there is a risk of damage being caused to fruit trees, vegetable gardens, citrus plantations, cereal crops or vineyards shall be entered ;
- (e) hunters shall carry with them their game licence, their gun possession licence and the certificate of registration of their gun.

**SCHEDULE**

All the areas north of the Episkopi Cantonment and Paramali married quarters which are within the village boundaries of Sotira and Paramali respectively (in so far as those villages lie within the Akrotiri Sovereign Base Area) other than the Game Reserve described in Public Instrument No. 92 of 1976.

THE GAME AND WILD BIRDS  
(PROTECTION AND DEVELOPMENT) ORDINANCE

(Ordinance 11 of 1974).

NOTICE UNDER SECTION 27 (1) (b).

In exercise of the powers conferred upon him by paragraph (b) of sub-section (1) of Section 27 of the Game and Wild Birds (Protection and Development) Ordinance, the Area Officer Akrotiri, with the approval of the Chief Officer, hereby authorises any holder of a valid game licence to shoot, take or pursue turtle-doves, wood pigeons, rock-pigeons, bee-eaters and other wild birds including such vermin as sparrows, crows, magpies, jackdaws and foxes, in the areas set out in the Schedule hereto during the period commencing on the 23rd April, 1978 and ending on the 14th May 1978, subject to the following terms and conditions :—

- (a) shooting shall take place between sunrise and sunset ;
- (b) no dogs shall be used ;
- (c) there shall be no shooting within 200 yards of any service installations or within 100 yards of the perimeter of the RAF Station Akrotiri ;
- (d) no fires shall be kindled ;
- (e) there shall be no shooting within 300 yards of Akrotiri village built-up area or in any private fenced up land ;
- (f) no farm or other cultivated land where there is a risk of damage being caused to fruit trees, vegetable gardens, citrus plantations, cereal crops or vineyards shall be entered ;
- (g) hunters shall carry with them their game licence, their gun possession licence and the certificate of registration of their gun.

SCHEDULE

All that area in the Akrotiri Sovereign Base Area which lies south of the Limassol—Paphos trunk road up to the junction of the Curium beach road and thence south east of the road in question, other than any game reserves which lie within the said area and the area described below—

The boundary commences at B.P. 242; thence it runs in a northerly and north easterly direction along the SBA boundary up to the junction of an earth track between Zakaki and Kolossi; thence in a westerly direction along that track up to an earth track running southwards; thence along that track up to the SBA boundary; thence along the said boundary up to B.P. 220; thence in a westerly direction along an earth track up to its junction on the main Kolossi—Akrotiri road; thence in a southerly direction along that road up to the M. 1 junction; thence in a westerly direction along that road up to the M. 1 bridge; thence in a south easterly direction along an earth track; thence along the western fence of the Fassouri farm up to the Upper Marsh track; thence in a south easterly direction along that track and the boundary of the Akrotiri Main State Forest as far as B.P. 242, the point of commencement.
