**THE MOTOR VEHICLES
(THIRD PARTY INSURANCE) ORDINANCE**

(Cap. 333 and 7 of 1960 — Laws of Cyprus — and
Ordinance 5 of 1966).

ORDER MADE BY THE ADMINISTRATOR UNDER SECTION 2.

In exercise of the powers vested in him by Section 2 of the Motor Vehicles (Third Party Insurance) Ordinance, the Administrator hereby makes the following Order :—

1. This Order may be cited as the Motor Vehicles (Third Party Insurers) (Consolidation) (Amendment) (No. 3) Order, 1978 and shall be read as one with the Motor Vehicles (Third Party Insurers) (Consolidation) Order, 1978, as amended from time to time (hereinafter referred to as “the principal Order”).

2. Paragraph 2 of the principal Order is hereby amended by including as item “16A”, immediately after item 16, the following insurance company :—

“16A. Libano — Suisse S. A. L. Insurance Company”.

THE EXCHANGE CONTROL ORDINANCE

(Cap. 199 — Laws of Cyprus — and Ordinance No. 6 of 1972).

ORDER MADE UNDER SECTION 33.

In exercise of the powers vested in me under Section 33 of the Exchange Control Ordinance, I, the Fiscal Officer, make the following Order :

1. This Order may be cited as the Exchange Control (Gold Coins' Exemption) Order, 1978.

2. There shall be exempted from the provisions of Section 3 of the Ordinance—

- (a) any purchase and sale of any gold coin by a person, being at the time of purchase or sale in the Areas, if both purchaser and seller are residents of the Island of Cyprus and do not act on behalf of a non-resident of the Island of Cyprus ;
- (b) every borrowing of any gold coin by a person being at the time of borrowing in the Areas, if both lender and borrower are residents of the Island of Cyprus and do not act on behalf of a non-resident of the Island of Cyprus.

3. There shall be exempted from the provisions of Sections 4 and 5 of the Ordinance every gold coin obtainable in accordance with paragraph 2 of this Order.

4. The Exchange Control (Collectors' Pieces Exemption) Order, 1953 is hereby revoked :

Provided that there shall be exempted from the provisions of Sections 4 and 5 of the Ordinance every gold coin which, on the date of publication of this Order in the Gazette was available in the Island of Cyprus.

THE EXCHANGE CONTROL ORDINANCE

(Cap. 199 — Laws of Cyprus — and Ordinance No. 6 of 1972).

ORDER MADE UNDER SECTION 33.

In exercise of the powers vested in me under Section 33 of the Exchange Control Ordinance, I, the Fiscal Officer, make the following Order :

1. This Order may be cited as the Exchange Control (Temporary Visitors' Exemption) Order, 1978.

2. Any person who is not resident of the Island of Cyprus shall be exempted from Section 4 of the Ordinance :

Provided that this exemption is not applicable to any gold coin made available in the year 1977 or any subsequent year under the provisions of any legislation of the Areas or the Republic.

3. The exchange Control (Temporary Visitors' Exemption) Order, 1953 is hereby revoked.
