**THE MOTOR VEHICLES AND ROAD TRAFFIC
ORDINANCE**

(Ordinance No. 8 of 1973).

ORDER MADE UNDER SUB-SECTION (2) OF SECTION 4.

In exercise of the powers conferred upon me by sub-section (2) of Section 4 of the Motor Vehicles and Road Traffic Ordinance, 1973, I, the Chief Officer, hereby make the following Order :—

1. This Order may be cited as the Speed Limits (Amendment) Order, 1979 and shall be read as one with the Speed Limits Order, 1978 (hereinafter referred to as "the principal Order").

2. The Schedule to the principal Order is hereby amended :—

(a) by deleting in Part II thereof the particulars of items (11) and (12) respectively, set out in columns 1 and 2 of the said Part II, and substituting therefor, in the said two columns, the following particulars :—

Column 1	Column 2
Road	Maximum Speed Limit (miles per hour)
“(11) Blandford Avenue (12) Asford Road	30 30” ;

(b) by inserting immediately after item (12) of Part II thereof the following new item, to be numbered (13), containing the particulars set out therein in each of the respective two columns of the said Part II :—

Column 1	Column 2
Road	Maximum Speed Limit (miles per hour)
“(13) Pioneer Road	30.”.

No. 5**THE CUSTOMS AND EXCISE DUTIES ORDINANCE, 1978**

(Ordinance No. 12 of 1978).

ORDER MADE UNDER SUB-SECTION (1) OF SECTION 14.

In exercise of the powers vested in him by sub-section (1) of Section 14 of the Customs and Excise Duties Ordinance, 1978 the Administrator hereby makes the following Order :—

1. This Order may be cited as the Gold and Silver Coins and Medals Order, 1979.

2. The importation of gold or silver coins and gold or silver medals by a person, corporate or incorporate, except under and in accordance with the terms of a licence granted in respect of the said importation by the Fiscal Officer, in consultation with the Authorities of the Central Bank of Cyprus as defined in the Central Bank of Cyprus and Republican Currency (Recognition) Ordinance, 1963 (Ordinance No. 28 of 1963), is hereby prohibited.

(REGULATION AND CONTROL) ORDINANCE**

**CONTROL AND MAXIMUM PRICE ORDER
MADE UNDER SECTIONS 3 (1) AND 4 (1).**

In exercise of the powers vested in him by sub-section (1) of Sections 3 and 4 of the Commodities and Services (Regulation and Control) Ordinance, the Administrator hereby makes the following Order :—

1. This Order may be cited as the Commodities and Services (Regulation and Control) (Maximum Price of Imported Frozen Lamb) (Amendment) Order, 1979 and shall be read as one with the Commodities and Services (Regulation and Control) (Maximum Price of Imported Frozen Lamb) Order, 1974 as amended from time to time (hereinafter referred to as "the principal Order").
