GAME RESERVE ORDER.

---

In exercise of the powers vested in him by subsection (1) of Section 29 of the Game and Wild Birds (Protection and Development) Ordinance, 1974 the Administrator hereby declares the area specified in the Schedule hereto to be a Game Reserve—

**S C H E D U L E**

The boundary commences at culvert No. 71/3 on the Limassol-Paphos road (grid reference 825373 of Cyprus map, sheet 23, Series K 717, Edition 2 — GSGS); thence it runs in a northerly direction along a watercourse up to a point where it meets the overhead power line (11 KV); thence in a straight line along the said power line in an easterly direction up to an electricity pylon north of certain military barracks; thence north east along the overhead power line (11 KV) to GR 858390 and thence east in a straight line to the track leading to Sotira village; thence in a southerly direction along the said track which crosses the Episkopi rubbish dump; thence along the said road up to a point outside the receiver aerial farm; thence along the edge of the said aerial farm and along the Sotira track up to an electricity sub-station; thence eastwards within a radius of 400 yards from Curium Stadium and other antiquity sites up to the Limassol-Paphos road; thence westwards along the said road up to the point of commencement.

The area outlined above is more specifically shown on a map which is open to inspection by any interested person at the Sovereign Base Area Office, Akrotiri and is demarcated by appropriate sign posts on the ground.

The Game Reserve Order published as P. I. No. 92 of 1976 and Area 'F' in the Schedule to P. I. No. 33 of 1979 are hereby revoked.
