THE GAME AND WILD BIRDS
(PROTECTION AND DEVELOPMENT) ORDINANCE, 1974

(Ordinance 11 of 1974).

ORDER MADE UNDER SECTION 6.

In exercise of the powers conferred upon me under Section 6 of the Game and Wild Birds (Protection and Development) Ordinance, 1974, I, the Chief Officer, hereby order as follows :—

1. This Order may be cited as the Game (Ceiling) Order, 1981.
 2. The number of game that may be shot or possessed by the holder of a game licence on any one day shall not exceed five partridges, or four partridges and one francolin.

THE MOTOR VEHICLES AND ROAD TRAFFIC ORDINANCE

(Ordinance No. 8 of 1973).

ORDER MADE UNDER SUBSECTION (2) OF SECTION 4.

In exercise of the powers conferred upon me by subsection (2) of Section 4 of the Motor Vehicles and Road Traffic Ordinance, 1973, I, the Chief Officer, hereby make the following Order :—

1. This Order may be cited as the Speed Limits (Sovereign Base Areas of Akrotiri and Dhekelia) Order, 1981.

2. All roads within the Sovereign Base Areas of Akrotiri and Dhekelia shall be subject to a maximum speed limit of 50 miles per hour except where a lesser speed limit has been imposed by the Speed Limits Order, 1978 as amended from time to time.

3. Public Instruments Nos. 72 and 73 of 1979 are hereby revoked.
