**CONSTITUTION OF SPECIAL COMMITTEE.**

It is hereby notified for general information that the persons whose names are shown below shall constitute the Special Committee for the administration and control of specified property in Akrotiri village, and shall hold office as such, from 26th October 1982 for a period of three years. Those whose names are numbered 1 and 2 are the officers of the Republic nominated by the Administrator in consultation with the appropriate authorities of the Republic; the person whose name is numbered 3 is a member of the Committee ex-officio; and the persons whose names are numbered 4 to 7 inclusive, being properly qualified persons, were elected to the Committee following an election held at Akrotiri village on 10th October, 1982.

ORDER MADE UNDER SECTION 7.

In exercise of the powers conferred upon me under Section 7 of the Game and Wild Birds (Protection and Development) Ordinance, 1974, I, the Chief Officer, hereby order that the shooting of game and wild birds shall during the game season take place only between sunrise and sunset :

Provided that duck may be shot between sunset and sunrise in the Akrotiri Sovereign Base Area.
