APPOINTMENT OF COMPETENT AUTHORITY  
UNDER DEFENCE REGULATION 3.

In exercise of the powers conferred upon him by Defence Regulation 3 as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946 the Administrator hereby appoints the Chief Officer to be the Competent Authority for the purposes of all the Defence Regulations set out in the said Schedule to such Order in which such expression occurs.

ORDER MADE UNDER SECTIONS 2 AND 26.

In exercise of the powers vested in him by Sections 2 and 26 of the Game and Wild Birds (Protection and Development) Ordinance, 1974 the Administrator has prescribed that the periods specified in the Schedule hereto shall be a close season in addition to the close season as defined in Section 2 of the Ordinance.

**SCHEDULE**

- (a) the period between 1st October, 1983 and 12th November, 1983, both days inclusive.
  - (b) The period between 26th and 31st December, 1983, both days inclusive.
  - (c) All days in the week during a non-close season except Wednesdays and Sundays.

ORDER MADE UNDER SECTION 6.

---

In exercise of the powers conferred upon me under Section 6 of the Game and Wild Birds (Protection and Development) Ordinance, 1974, I, the Chief Officer, hereby order as follows :—

1. This order may be cited as the Game (Ceiling) Order, 1983.
  2. The number of partridges that may be shot or possessed by the holder of a game licence on any day shall not exceed five.
