CONSTITUTION OF SPECIAL COMMITTEE.

It is hereby notified for general information that the persons whose names are shown below shall constitute the Special Committee for the administration and control of specified property in Akrotiri village and shall hold office as such, until the 25th October, 1985. Those whose names are numbered 1 and 2 are the officers of the Republic nominated by the Administrator in consultation with the appropriate authorities of the Republic; the person whose name is numbered 3 is a member of the Committee ex-officio; and the persons whose names are numbered 4 to 7 inclusive, being properly qualified persons, were elected to the Committee following an election held at Akrotiri village on 10th October, 1982.
