**THE PETROLEUM SALES (REGULATION) ORDINANCE**

(Ordinances 4 of 1979, 19 of 1980 and 8 of 1984).

**ORDER MADE BY THE ADMINISTRATOR  
UNDER SECTION 3(4).**

In exercise of the powers conferred upon him by subsection (4) of Section 3 of the Petroleum Sales (Regulation) Ordinance, the Administrator hereby makes the following Order:—

1. This Order may be cited as the Petrol Stations (Sunday Operation Hours) Order, 1985.

2. The Petrol Stations set out in the first column of the Schedule hereto may remain open on the dates set out, opposite their description, in the second column of the said Schedule during the following periods:—

- (i) The period from and including 1st April to 30th September of every year from 7 a.m. to 5 p.m.
- (ii) The period from and including 1st October to 31st March of every year from 7 a.m. to 4 p.m.

**THE GAME AND WILD BIRDS  
(PROTECTION AND DEVELOPMENT) ORDINANCE, 1974**

(Ordinances 11 of 1974 and 1 of 1982).

**GAME RESERVE ORDER.**

In exercise of the powers vested in him by subsection (1) of Section 29 of the Game and Wild Birds (Protection and Development) Ordinance, 1974 the Administrator hereby declares the area specified in the Schedule hereto to be a Game Reserve—

**SCHEDULE**

The boundary commences at GR 814374 where the old Limassol-Paphos road joins the new road at Paramali Station; thence it runs along the former road in a northerly and easterly direction to GR 833387 and thence in a southerly and easterly direction until it meets the overhead power line (11KV) at GR 836381; thence in a straight line along the said power line in an easterly direction up to an electricity pylon north of certain military barracks; thence north east along the overhead power line (11KV) to GR 858390 and thence east in a straight line to the track leading to Sotira Village; thence in a southerly direction along the said track which crosses the Episkopi rubbish dump; thence along the said road up to a point outside the receiver aerial farm; thence along the edge of the said aerial farm and along the Sotira track up to an electricity sub-station; thence eastwards within a radius of 400 yards from Curium Stadium and other antiquity sites up to the Limassol - Paphos road; thence westwards along the said road up to the point of commencement.

The area outlined above is more specifically shown on a map which is open to inspection by any interested person at the Sovereign Base Area Office, Akrotiri and is demarcated by appropriate signposts on the ground.

The Game Reserve Order published as P. I. No. 15 of 1984 is hereby revoked.

THE SUMMER TIME ORDINANCE

(Cap. 98 — Laws of Cyprus).

ORDER MADE BY THE ADMINISTRATOR  
UNDER SUBSECTION (1) OF SECTION 2.

In exercise of the powers vested in him by subsection (1) of Section 2 of the Summer Time Ordinance, the Administrator hereby makes the following Order :—

1. This Order may be cited as the Summer Time Order, 1985.
2. In the period specified in the Schedule hereto the time for legal and general purposes in the Areas shall be three hours in advance of Greenwich Mean Time.

SCHEDULE

From 00.00 hrs (Greenwich Mean Time) on the 31st March, 1985 to 24.00 hrs (Greenwich Mean Time) on the 28th September, 1985.
