THE ANNUAL HOLIDAYS WITH PAY
ORDINANCE, 1973

(Ordinances 10 of 1973, 12 of 1979
and 21 of 1980).

ORDER UNDER SECTION 5(2).

In exercise of the powers vested in me under subsection (2) of Section 5 of the Annual Holidays With Pay Ordinance, I, the Chief Officer hereby increase the number of days of holiday provided for in subsection (1) of Section 5 of the aforesaid Ordinance :

1. Where an employee is working five days a week from ten to thirteen working days as from 1st June, 1986 and to fifteen working days as from 1st January, 1987.
 2. Where an employee is working six days a week from twelve to fifteen working days as from 1st June, 1986 and to eighteen working days as from 1st January, 1987.
