THE GAME AND WILD BIRDS (PROTECTION AND
DEVELOPMENT) ORDINANCE, 1974

(Ordinances 11 of 1974, 1 of 1982 and 3 of 1985).

ORDER MADE UNDER SECTION 10.

In exercise of the powers vested in him by paragraph (b) of subsection (1) of Section 10 of the Game and Wild Birds (Protection and Development) Ordinance, the Administrator hereby prohibits the shooting, killing, taking, pursuing or selling of francolin during the 1986 game season as prescribed in Public Instrument No. 75 of 1986.
