ORDER MADE BY THE ADMINISTRATOR UNDER SECTION 3.

In exercise of the powers conferred upon him by Section 3 of the Powers and Duties (Officers of the Republic of Cyprus) (Consolidation) Ordinance, 1976, and of all other powers enabling him in that behalf, the Administrator hereby makes the following Order :—

THE GAME AND WILD BIRDS  
(PROTECTION AND DEVELOPMENT) ORDINANCE

(Ordinances 11 of 1974, 1 of 1982 and 3 of 1985).

ORDER MADE UNDER SECTION 30.

---

In exercise of the powers conferred upon me under Section 30 of the Game and Wild Birds (Protection and Development) Ordinance, 1974, I hereby declare the area defined in the Schedule hereto (other than the areas already declared as Game Reserve under Public Instrument No. 61 of 1985) to be a temporary Game Reserve for the period beginning on 19th November 1986 and ending on 31st December 1986.

SCHEDULE

The area commences at a point where the eastern bank of Kouris river meets the coast; thence in a northeasterly direction to the southeastern part of the Queen's Bridge on the M. 1; thence in an easterly direction, along the southern side of the M. 1 and Trakhoni roads to B.P. 220; thence in a southerly direction, along the SBA boundary, to B.P. 266, which is on the coast; thence round the Akrotiri peninsula, in a southerly, westerly and northerly direction to the point of commencement. All which area is signposted on the ground.
