**THE STREETS AND BUILDINGS REGULATION  
(CONSOLIDATION) ORDINANCE, 1984**

(Ordinances 7 of 1984 and 2 and 13 of 1987).

**NOTICE UNDER SECTION 15.**

In exercise of the powers vested in him by subsection (1)(d) of Section 15 of the Streets and Buildings Regulation (Consolidation) Ordinance, 1984, the Acting Area Officer Akrotiri, as the Appropriate Authority for the Sovereign Base Area of Akrotiri, does hereby, with the approval of the Administrator, define that within the area described in the Schedule hereto, the maximum total area of all storeys of buildings taken together, shall not exceed 1% (one per centum) of the area of the site upon which such buildings are to be erected; all which area is more particularly defined on Plan 1/87, signed and dated the 21st day of October, 1987 and deposited at the Akrotiri Area Office at Phassouri.

2. Public Instrument No. 9 of 1986 is hereby revoked without prejudice to anything done or left undone thereunder.

THE GAME AND WILD BIRDS  
(PROTECTION AND DEVELOPMENT) ORDINANCE, 1974

(Ordinances 11 of 1974, 1 of 1982 and 3 of 1985).

---

ORDER MADE UNDER SECTION 6.

---

In exercise of the powers conferred upon the Chief Officer under Section 6 of the Game and Wild Birds (Protection and Development) Ordinance, 1974 I, the Acting Chief Officer, hereby order as follows :—

1. This Order may be cited as the Game (Ceiling) Order, 1987.
2. The number of hares that may be shot or possessed by the holder of a game licence shall not on any one day exceed two.
3. The number of partridges that may be shot or possessed by the holder of a game licence shall not, on any one day during the period 8th November, 1987 to 15th November, 1987 inclusive, exceed five.
4. Subject to the provisions of this paragraph, the number of partridges that may be shot or possessed by the holder of a game licence shall not, on any one day during the period 18th November, 1987 to 27th December, 1987 inclusive exceed five :

Provided that such holder may on any one day during such period shoot or possess one francolin, but in such case the number of partridges that may be shot or possessed by such holder shall not, on any one day during such period exceed four.

5. Nothing in this Order shall apply to the possession of hares, partridges or francolin by any person who is entitled to possess such game under Section 11 of the Ordinance.

ORDER MADE UNDER SECTION 10.

In exercise of the powers vested in him by paragraph (b) of subsection (1) of Section 10 of the Game and Wild Birds (Protection and Development) Ordinance, the Administrator hereby prohibits the shooting, killing, taking, pursuing or selling of francolin during the period 8th November, 1987 to 15th November, 1987 inclusive.
