ORDER MADE BY THE ADMINISTRATOR UNDER SECTION 6.

---

In exercise of the powers conferred upon him by Section 6 of the Agricultural Insurance (Facilitation of Republican Agricultural Insurance Scheme) Ordinance, 1977 the Administrator hereby prescribes the following agricultural crops as being compulsorily insurable by all insured persons :-

- (a) Deciduous Fruit Trees.
  - (b) Vines :
    - (i) Wine making varieties,
    - (ii) Table varieties.
  - (c) Cereals :
    - (i) Wheat,
    - (ii) Barley.
  - (d) Potatoes.
  - (e) Citrus.
  - (f) Dry land fodder crops.
  - (g) Horticultural crops.
  - (h) Beetroots.
  - (i) Carrots.
  - (j) Tropical and other fruit producing varieties.
2. Public Instrument No. 11 of 1989 is hereby revoked.

**THE AGRICULTURAL INSURANCE  
(FACILITATION OF REPUBLICAN AGRICULTURAL  
INSURANCE SCHEME) ORDINANCE, 1977.**

(Ordinances 11 of 1977, 7 of 1978, 7 of 1980,  
4 of 1985, 12 of 1987 and 3 of 1989).

REGULATIONS MADE UNDER SECTION 7 (2).

In exercise of the powers vested in him by subsection (2) of Section 7 of the Agricultural Insurance (Facilitation of Republican Agricultural Insurance Scheme) Ordinance, 1977 the Chief Officer, in consultation with the Republican Agricultural Insurance Board, hereby directs that the premium payable to the Republican Board by insured persons shall be assessed on a percentage basis in relation to the gross return from each crop as set out below:-

Type of Crop	Unavoidable Natural Causes Covered	Extent of Premium per centum
(a) Deciduous Fruit Trees	Hail	3 %
(b) Vines:		
(i) Wine making varieties	Hail, frost, heat-wave	3 %
(ii) Table varieties	Hail, frost, heat-wave	3 %
(c) Cereals:		
(i) Wheat	Drought, hail and rust	3 %
(ii) Barley	Drought, hail and rust	3 %
(d) Potatoes	Hail, frost, flood	3 %
(e) Citrus	Frost, hail, wind-storm	3 %
(f) Dry land fodder crops	Drought, hail	3 %
(g) Horticultural crops	Hail, frost, wind-storm	3 %
(h) Beetroots	Hail, frost, flood	3 %
(i) Carrots	Hail, frost, flood	3 %
(j) Tropical and other fruit producing varieties	Hail, frost	3 %

**ORDER MADE BY THE ADMINISTRATOR

In exercise of the powers conferred upon him by Section 10 of the Powers and Duties (Officers of the Republic of Cyprus) (Consolidation) Ordinance, 1976 and all other powers enabling him in that behalf, the Administrator hereby makes the following Order:—
