THE BOMBARDMENT RANGE AREAS ORDINANCE

(Cap.213 - Laws of Cyprus).

NOTICE UNDER SECTION 2.

In exercise of the powers vested in him by Section 2 of the Bombardment Range Areas Ordinance, the Administrator hereby declares the areas set out in the Schedule to this Notice to be a Bombardment Range Area for use by Her Majesty's Forces, until further notice, as practice areas for the purposes specified in the said Section.

2. That part of P.I. No.8 of 1983 relating to the Pyla Bombardment Range Area is hereby revoked.

SCHEDULE**The Pyla Bombardment Range Area.**

(1) Sea Danger Area:- That area of the territorial waters of the Sovereign Base Areas contained inside a line drawn through the following positions on Admiralty Chart No. 851 of the 8th August 1941:-

to	34°56.86'N	33°49.02'E
to	34°56.60'N	33°48.60'E
to	34°54.80'N	33°48.10'E
to	34°53.60'N	33°50.30'E
to	34°53.40'N	33°52.60'E

to	34°57.02'N	33°57.76'E

(2) Land Danger Area:- The boundary commences at Grid Reference, 76146922, and follows a line joining the following Grid References: 76476983, 77116984, 78526846, 79276873, 79306856, 79806840, 80306795 on the Map 1:50,000 Cyprus, Series K 717 Sheet 14 Famagusta.

THE BOMBARDMENT RANGE AREAS ORDINANCE

(Cap. 213 - Laws of Cyprus).

REGULATIONS MADE UNDER SECTION 3.

In exercise of the powers vested in him by Section 3 of the Bombardment Range Areas Ordinance, the Administrator hereby makes the following Regulations:-

1. These Regulations may be cited as the Bombardment Range Areas (Amendment) Regulations, 1994 and shall be read as one with the Bombardment Range Areas Regulations, 1983 (hereinafter referred to as "the principal Regulations").

P.I. No. 8/83.

2. Regulation 6 of the principal Regulations is hereby amended by deleting the word "Safety" appearing in the second line of paragraph (1) thereof and substituting therefor the word "Conducting".

3. Regulation 18 of the principal Regulations is hereby revoked and replaced with the following Regulation:-

"18. In this part of these Regulations the "Pyla Bombardment Range Area" means the area declared as such under Section 2 of the Ordinance by notice published in the Supplement No.3 to the Gazette of the 11th day of April 1994, or by any other notice amending or substituted for the same.

4. Regulation 19 of the principal Regulations is hereby revoked and replaced with the following Regulation:-

"19. The danger signals to be hoisted in respect of the Pyla Bombardment Range Area shall be as follows:-

(a) By Day:

- (i) A series of ten red flags hoisted along the boundary of the Land Danger Area;
- (ii) a red flag displayed from a boat patrolling outside the limits of the Sea Danger Area or, where weather conditions are such that the said boat is unable to put to sea, a red flag displayed on a boat moored alongside Romantzo's Jetty;

(b) By Night:

- (i) A series of red lights displayed along the boundary of the Land Danger Area;
- (ii) a red light displayed from a boat patrolling outside the limits of the Sea Danger Area or, where weather conditions are such that the said boat is unable to put to sea, a red light displayed on a boat moored alongside Romantzo's Jetty.

THE MOTOR VEHICLES (THIRD PARTY INSURANCE)

2. Paragraph 2 of the principal Order is hereby amended by inserting in the appropriate alphabetical order the following new Insurance Company : -

"Ledra Insurance Ltd."
